

Township of Bloomington
Monday March 1st, 2021
Regular Monthly Board Meeting Minutes

The regular monthly board meeting of the Town of Bloomington was called to order on Monday March 1st, at 7:05 pm by Chairman Greg Patterson. Other members present were Town Supervisors William Erdenberger, Joe Kirschbaum, Clerk Jane Patterson and Patrolman Andrew (Buck) Crubel. Public member in attendance was Michelle Newhouse. Motion (Joe Kirschbaum), seconded (Greg Patterson) was made to approve posting of the March meeting/agenda notice, motion carried. Motion (Greg Patterson), seconded (Bill Erdenberger) was made to approve the February Board Meeting minutes, motion carried. Motion (Bill Erdenberger), seconded (Joe Kirschbaum) was made to approve the January 2021 Caucus Meeting minutes, motion carried.

There were no Appearances/Public Comments.

Roads: Roads are in good winter driving condition. Patrolman Crubel said he will start posting weight limit signs for the roads this week. Several companies have contacted Chairman Patterson and Patrolman Crubel about seal coating/crack filling and gravel bids. Scott's Construction Co said that Hickory Road (from Maine Rd to Blake Hollow Barn) if seal coated, the road edge needs to be built up to avoid cracking/breaking. Clerk Jane Patterson received an email from the WI DOT informing us that only a third of the Hickory Road Extension will be put on our GTA map this year. Due to snow and ice, the DOT surveyors who came to inspect the road could not make it to the end. The Board and Patrolman will look at the road again this spring/summer to see what can be done to acquire approval from the DOT and resubmit the request this fall.

Machinery Report: Patrolman Andrew Crubel reported that Fabick has not looked at the grader yet, but the serviceman should be here within the next week or two, otherwise the machinery is in good working condition.

Clerk Jane Patterson presented the February 2021 financial report. The board unanimously agreed to pay outstanding bills. Clerk Jane Patterson reported that five Personal Properties were omitted from the 2020 Assessment Roll, therefore they did not receive 2020 Personal Property tax bills. Clerk Patterson has been in contact with the WI DOR, our assessor, Grant Cty Tax Lister and Grant Cty Treasurer about the errors. The omitted taxes have been reported to the DOR; Clerk Patterson created tax bills for these properties and sent them to the owners. Due to the covid-19 virus, motion (Greg Patterson), seconded (Bill Erdenberger) was made to waive the alcohol license fee for the Blake Hollow Barn 2021/2022 (one year) license renewal, on a voice roll call Yes-3, No-0, motion carried. Blake Hollow Barn will be responsible for the newspaper publication and operator's license. The total number of voters at the February Primary Election was ten. The Spring Election will be held Tuesday April 6th, 2021.

Next Monthly Board Meeting will be Monday, April 5th, 2021
