Property Owner agrees to NOT TRANSFER assigned space in the Storage Lots to New Owners of their property nor any other Member of MVSHOA.

Property Owner understands that all boats, trailers, or other authorized articles placed in the Storage Lots or Boat Ramp Area are done so entirely at the owner's risk. MVSHOA is NOT responsible for any loss, damage, or theft thereto.

Only Members of MVSHOA and their family members may have access to the Storage Lots.

Property Owner's are responsible to notify MVSHOA of any changes to their equipment parked in storage lots. (new trailer, moving out, etc.)

All boat trailers or authorized equipment parked in the Storage Areas shall be maintained in operable condition and shall be identified by a legible and valid MVSHOA DECAL

Items left in the Storage Area(s) that are not identified by a MVSHOA DECAL may be subject to removal and disposition by action of the MVSHOA Board of Directors.

Property Owner agrees that the Storage Lot Key will only be used by Property Owners or their family members,

Upon request Property Owners will be furnished one (1) Boat Ramp Access Key free of charge.

Property Owner agrees that personal Boat Ramp Access Key will only by used by Property Owner or their family members.

Property Owner will not turn Boat Ramp Access Key over to others, nor will they allow unauthorized access to MVSHOA controlled areas.

Boat Ramp Access Key for Renters - Owner is responsible to assure occupants and their guests follow regulations set forth for all MVSHOA property owners.
