Vice President's Update

The following actions/items were completed in the month of March, 2021:

- ➤ MVS Urban Archery officially ended March, 28, 2021. A total of 10 archery hunters registered and hunted in designated areas of MVS from January through March, 2021.
 - One recorded kill.
 - Success of the program will be discussed impeding factors: 2nd legal time period (January through March) not as productive as first (September to

December), significant increase in construction in the MVS neighborhood, ice and snow periods, restrictive, non-contiguous hunting areas.

- Motion was made to send a retainer to the Chadwick/Washington Legal Firm so that the Board can ask for help in reviewing recorded documents and other questions that may arise in the future. The Board voted unanimously in favor of this action.

Grounds and Maintenance

Rip rap to complete renovation of dam at boat ramp, and as approved by the Board, was ordered and delivered. Intent is to limit wash down of silt and debris into the lake. Gary Erickson headed the effort for the community.

Requested Roaches to remove a large fallen tree from Capewood roadside after spontaneous (and dangerous) fall. Passersby helped move the tree to the side using dually pick-up, and then cleaned up road debris.

To be on the safe side, the spring cleanup event will be organized the same as 2020, and we will not have a volunteer picnic. An email was sent out on April 12th to the community requesting small work teams be assembled to get the jobs done by the end of May. The Board is looking forward to planning the usual spring cleanup day and volunteer picnic in 2022.
