- Rick expressed his appreciation to Randy Strong and Jim Wilson and team in fixing the water leak at the Post.
- There will be a celebration of life and bridal shower at the Post this weekend.
- The Carmel Rugby Club is doing a great job on maintaining the field and property. On Tuesday, August 9 at 6pm they will be holding a banquet to celebrate the victories of the Boys and Girls Club state championship. The Post should have several members attend this attend to show these youths what it is like to be a vet, what does it mean, etc. They will also present the Post a \$1,000 check.

#### **Open Business Items:**

- Rick and Joe met to discuss how to remediate the sprinkler question. We believe we have some leeway in managing the sprinklers, but they will need to meet with the Fire Marshall to understand the Carmel requirements.
- The process continues in trying to fill the Club Manager position. Mariah has agreed to help out as we continue to look to fill this position. A motion was made to give Rick flexibility in salary and job responsibilities in filling this position. Rick will solicit input from two other board members as needed. Greg Watson seconded the motion and the motion passed.
- Honor Guard. David Leonard will work with Greg Watson to determine who to issue the ceremonial rifles when needed.

#### **New Business Items:**

- Pull Tab Machine. We were advised that our current Pull Tab machines leases are up an these machines will no longer be serviced. Rick was approached about the availability of used machine that is still serviceable. Rick will validate the purchase price and advise the board through electronic communication.
- Meat Raffle or Auction. We have been advised that we have an excess of meat in the freezer. Greg suggested we look at holding a Meat Raffle to sell the excess meat. Greg will meat with a contact of his who has done something similar at another Post. Greg will advise within the next few days.
- New Menu. The new Post menu will be effective August 22. In addition, we will be offering a special on Wed and Friday. The kitchen will remain closed on Saturday and Sunday.
- Website and Email. David advised he is closer in getting mass email communication process worked out. The Post will need to create two additional email accounts (commander and club manager). All Post emails will be another medium on getting information about the post out to the membership.
- Commander Meeting. Rick will be holding the first All Post Commander meeting on Aug 17 at 7pm. We will be working on the various ways to get the information out to the members.
- Joe Hunter-Lattak brought up the following items:
  - Make available all rules associated with our various gaming opportunities. We believe this information is available in the Post. Those rules will be found and made available.
  - We need to develop a new member communication packet and brochure. David will get with Joe to discuss further.
  - The Post needs to enhance our communication and program on renting out our available spaces. Our facilities are a good revenue source we should manage.
- Phil Poor brought up the following items:
  - The front and back doors need to be locked at 8:30pm to enhance security at the Post. Greg motioned that the front door be located after 8:30 and the appropriate signs be displayed. The motion was seconded and passed unanimously.
  - The windowsills in the patio are in need of repair. Phil should reach out to Andy and determine next steps.
