By booking a session, enrolling in a curriculum, purchasing course materials, or engaging with Timeless Rhythm Group (TRG™), you expressly agree to the following terms and conditions. These policies are designed to maintain a professional, high-standard environment for all students and directors.

1. PUNCTUALITY & THE 10-MINUTE RULE

To maintain the integrity of our scheduling and show mutual respect for all clients:

- **The Grace Period:** TRG observes a strict **10-minute grace period** for all 1-on-1 mentorship sessions and consultations.
- **Automatic Cancellation:** If a student fails to arrive or log into the session within 10 minutes of the scheduled start time, the session is classified as a **"No-Show"** and will be automatically cancelled.
- **Forfeiture of Fees:** Sessions cancelled due to exceeding the 10-minute grace window are non-refundable and cannot be rescheduled.
- **Fixed End Times:** If you arrive within the 10-minute grace period, your session will conclude at the originally scheduled time. Lost time will not be extended.

2. CANCELLATION & RESCHEDULING

- **24-Hour Notice Required:** All cancellations or requests to reschedule a session must be submitted at least **24 hours prior** to the scheduled start time.
