WHO IS WHO?

Case Manager

A special education teacher or related service provider who:

- Serves as your first point of contact.
- Is responsible for monitoring your child's Individualized Education Program (IEP) implementation.
- Ensures special education procedural requirements occur
- Shares information about your child's IEP with all his/her teachers.
- Is available to meet outside of the IEP process to discuss information about special education at your child's school.

Instructional Team Leader (ITL)

- Provides support to the special education department for instruction, procedures and professional learning.
- Is available to answer questions about special education instruction and services at your child's school.

Central Office Special Education Resource Teacher and Instructional Facilitator

- Serves as a resource to the school staff and parents.
- Provides direct support to school teams to implement individualized instructional programs.
- Supports IEP teams with compliance processes.

FAMILY SUPPORT AND RESOURCE CENTER (FSRC)
