Seasonal trailer/boat storage is based on the total length of trailer and boat. (See current rates sheet for pricing)

Trailer locks and proof of insurance are required, and a key to the trailer lock must be kept at the marina office. The marina reserves the right to relocate trailer/boats in the case of an emergency, or in order to better serve everyone's needs. Storage space abandoned may not be sublet by the customer, and will revert back to the marina for the remainder of the contract term, with no refund made. Trailers must be marked on the tongue with the owner's name in weatherproof paint.

Storage must be paid in full before contract is accepted and space is occupied. Acceptance of this contract and rental of space does not guarantee any future storage rental.

Trailer/boat owners and/or their guests are not permitted to stay overnight aboard their vessels while stored on land at the marina. Transient slips are usually available for overnight stays, at an additional cost.

Boat owners are permitted to personally perform work on their own boats, provided they do so in accordance with paragraph (5) in the attached rules and regulations. Competitive labor and/or paid workmen are not permitted on the marina property without written authorization from Jersey Shore Marine Group, LLC. In-yard service should be arranged through Jersey Shore Marine Group, LLC.

Boat owners are not permitted to display FOR SALE signs on their boats while on the marina property.

No insurance of any kind is carried by the marina on boats or equipment. Boat owners are required to have insurance on their vessel, and provide proof thereof. The granting of trailer/boat storage hereunder is with a distinct and definite understanding, and the undersigned hereby agrees that Jersey Shore Marine Group, LLC assumes no responsibility whatsoever for personal injuries sustained by the undersigned, or any of the undersigned's guests on any part of the marina property, and assumes no responsibility for the safety of any vessel stored at the marina, and will not be liable for fire, theft, or damage to said vessel, its equipment, or any property in or on said vessel, however arising, reserving to Jersey Shore Marine Group, LLC the right to assume control and charge of any vessel for the protection of life and property in abnormal conditions or during catastrophes. The undersigned agrees to hold Jersey Shore Marine Group, LLC harmless for any legal costs or judgments associated with the personal injuries and/or losses to property referred to in this paragraph. Boat owners are responsible for any damage caused by their trailer/boat to the property or others.

The undersigned has read, understands and agrees to carry out and abide by all the rules and regulations of Jersey Shore Marine Group, LLC set forth above and attached, and any other reasonable rules and regulations as may be posted.
