# **Scope**

As a **Controlling Employer**, Pulsar Helium Inc. holds the ultimate authority and responsibility for ensuring the health, safety, and environmental integrity of all operations at its sites. This includes:

- Oversight of all work activities performed by employees, contractors, subcontractors, and vendors.
- Implementation of Safety Management Systems (SMS) that ensure compliance with all applicable federal, state, and local safety regulations.
- Coordination and communication of safety expectations and requirements to all personnel onsite.
- Enforcement of safety standards across all operational activities, including those performed by third-party contractors and vendors.

This policy applies to:

- All **Pulsar Helium Inc. owned and operated locations**, including project-specific environments and remote operations.
- **All personnel** under Pulsar Helium Inc.'s operational control, including employees, contractors, subcontractors, and visitors.
- **All activities** that impact health, safety, or the environment, including operational processes, equipment use, transportation, and emergency response.

# Responsibilities


### 1. Executive Management Responsibilities

Executive Management is responsible for:

- **Setting Safety Leadership Expectations:** Establishing safety as a core value and ensuring Zero Incidents remains the top priority.
- Resource Allocation: Providing adequate resources for safety systems, training, equipment, and personal protective equipment (PPE).
- Policy and Strategy Development: Developing and communicating safety policies and strategies, ensuring they reflect the responsibilities of a Controlling Employer.
- Performance Oversight and Accountability: Reviewing safety performance metrics, ensuring continuous improvement, and holding leaders accountable for safety outcomes.

### 2. HSE Manager Responsibilities

The HSE Manager is responsible for:





- Safety Program Development and Maintenance: Implementing and maintaining the Safety Management System (SMS) that governs all site activities.
- **Contractor Safety Management:** Ensuring all contractors and subcontractors comply with Pulsar Helium Inc.'s safety standards and regulatory requirements.
- **Hazard Identification and Risk Mitigation:** Conducting risk assessments, hazard analysis, and implementing control measures to prevent incidents.
- **Incident Investigation and Reporting:** Leading incident investigations to identify root causes and ensuring corrective actions are implemented to prevent recurrence.
- **Compliance Audits and Inspections:** Conducting regular safety audits and inspections to ensure compliance with all safety standards and regulations.

### 3. Supervisors and Team Leaders Responsibilities

Supervisors and Team Leaders are responsible for:

- **Daily Operational Oversight:** Monitoring daily operations to ensure compliance with safety standards and policies.
- **Coordination and Communication:** Coordinating safety activities among employees, contractors, and subcontractors to maintain a cohesive safety environment.
- **Training and Competency Verification:** Ensuring personnel are adequately trained and competent to perform tasks safely.
- **Stop Work Authority:** Exercising the authority to stop work immediately if unsafe conditions or practices are observed.
- **Incident Reporting and Investigation Participation:** Reporting incidents and near-misses promptly and actively participating in investigations.

#### 4. Employee and Contractor Responsibilities

All Employees and Contractors are responsible for:

- Adherence to Safety Practices: Following all safety practices, rules, and procedures set by Pulsar Helium Inc.
- **Hazard Identification and Reporting:** Reporting hazards, unsafe conditions, and incidents to supervisors immediately.
- **Proper Use of PPE and Safety Equipment:** Using personal protective equipment (PPE) and safety equipment as required.
- **Proactive Participation in Safety Programs:** Participating in safety training, meetings, and hazard assessments.



• **Stop Work Authority:** Exercising stop-work authority if hazardous conditions or unsafe acts are identified.

### 5. Third-Party and Vendor Responsibilities

Third Parties and Vendors are responsible for:

- **Compliance with Safety Standards:** Complying with all safety policies and procedures set by Pulsar Helium Inc. as the Controlling Employer.
- **Coordination and Communication:** Coordinating safety practices and communication with Pulsar Helium Inc. personnel to ensure cohesive safety management.
- Accountability and Responsibility: Maintaining accountability for the safety performance of their personnel and operations while on Pulsar Helium Inc. premises.
- **Incident and Hazard Reporting:** Promptly reporting incidents, near-misses, and hazards to Pulsar Helium Inc.'s supervisors or safety personnel.

# **Controlling Employer Responsibilities**

As the Controlling Employer, Pulsar Helium Inc. is ultimately responsible for:

- **Ensuring Site-Wide Safety Compliance:** Ensuring that all work performed at its sites complies with applicable federal, state, and local safety regulations, including OSHA requirements.
- **Communication of Safety Expectations:** Communicating safety expectations and requirements to all employees, contractors, and vendors.
- Coordinated Safety Oversight: Coordinating safety management and activities across all
  contractors, subcontractors, and vendors to ensure a cohesive and comprehensive safety
  environment.
- **Incident Management and Reporting:** Ensuring all incidents, near-misses, and hazards are reported, investigated, and documented accurately.
- **Enforcement of Safety Policies and Procedures:** Enforcing compliance with safety standards and taking corrective actions for violations.
- **Continuous Improvement and Performance Monitoring:** Continuously monitoring safety performance, conducting audits, and implementing improvements to achieve Zero Incidents.
