PARTICIPANT WAIVER AND RELEASE OF LIABILITY

Please read this document carefully. By registering, you agree to its terms. If you do not agree, do not participate in any class, program, or activity offered by Gardner Hive Athletics.

1. ASSUMPTION OF RISK

I understand and acknowledge that participation in sports, fitness classes, and athletic activities involves inherent risks of injury, including but not limited to: muscle strains, sprains, fractures, bruises, dislocations, concussions, heat-related illness, cardiovascular events, and other physical harm or death. These risks exist even when activities are conducted with proper supervision, instruction, and equipment.

I voluntarily assume all risks associated with participation in any and all Gardner Hive Athletics programs, classes, events, and activities, whether on the premises or at any off-site location.

2. WAIVER AND RELEASE OF LIABILITY

In consideration of being permitted to participate in Gardner Hive Athletics programs and activities, I, on behalf of myself and my heirs, executors, administrators, and assigns, hereby release, waive, discharge, and covenant not to sue Gardner Hive Athletics, its owners, officers, directors, employees, coaches, instructors, volunteers, agents, and representatives (collectively, "Released Parties") from any and all claims, demands, losses, liabilities, and causes of action arising out of or related to any loss, damage, or injury (including death) that may be sustained by me, whether caused by the negligence of the Released Parties or otherwise.

3. INDEMNIFICATION

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, actions, suits, judgments, and demands brought by others arising out of or related to my participation in Gardner Hive Athletics activities, including all legal costs and fees.

4. MEDICAL AUTHORIZATION

I certify that I am in good physical health and have no medical condition that would prevent my safe participation. I give permission for Gardner Hive Athletics staff to seek and authorize emergency medical treatment on my behalf if I am incapacitated and unable to do so myself. I understand I am responsible for all medical costs incurred.

5. TRANSPORTATION, DROP-OFF, AND PICK-UP POLICY

I explicitly understand and agree that parents and/or legal guardians are solely and strictly responsible for the timely drop-off and pick-up of participants. Gardner Hive Athletics does not provide transportation services and does not assume custody or responsibility for participants once they have been picked up or have departed from the premises at the conclusion of their scheduled program, class, or activity.

6. PHOTO AND MEDIA RELEASE

I grant Gardner Hive Athletics permission to photograph, record, and use images or video of me taken during activities for promotional, educational, and marketing purposes, without compensation.

7. RULES AND CONDUCT

I agree to follow all rules, regulations, and instructions provided by Gardner Hive Athletics staff. I understand that failure to comply may result in removal from the program without refund.

8. ACKNOWLEDGMENT

I have read this waiver and fully understand its terms. I understand that I am giving up substantial rights, including the right to sue. I acknowledge that I am signing this agreement freely and voluntarily.
