# AMPP (C5) Supervisor/Competent Person Refresher for Deleading Industrial Structures

*Completely updated in 2022, and again in 2023, this one-day refresher course provides a review of the competent person duties and responsibilities for protecting workers, compliance with OSHA and EPA regulations, waste streams and operations that result in potential exposures to lead and other hazards. C5 is required to be completed annually for people working with companies that are (SSPC QP2-certified (now AMPP), or on projects where the QP2 accreditation is required, or state accreditation is required. This course reviews both current regulations, and changes slated for 2025.*

- Painting Contractors, Abatement Contractors, Competent Persons, Specifying/Project Managers, Environmental Health and Safety (EH&S) Personnel, Engineers, Consultants, Inspectors, Facility/Risk Managers

## **Benefits of attending**

- Identify sources of hazardous coatings and materials, and the relative risks posed by industrial painting activities
- Describe the potential health effects of hazardous coatings/materials
- Implement controls and work practices necessary to protect the public, environment, and workers during industrial and hazardous coating removal activities
- OSHA and EPA regulations applicable to industrial painting activities

## **What this course covers...**

- Hazardous coatings and materials in industrial painting
- Legal and liability issues
- Air, soil, water/sediment and dust regulations and monitoring strategies
- Worker protection from hazardous coatings/materials
- Respiratory protection and PPE
- Management of solid and hazardous wastes
- Sources of hazardous coatings exposure
- Control of environmental releases (containment and ventilation)
- Specifications, submittals, and site-specific compliance programs
- Pre-planning and worksite preparation
- Competent Person (CP) responsibilities/demobilization

## **Course format:**

*Each participant will receive a comprehensive manual that includes references for additional reading and copies of relevant handouts. Hands-on workshops may accompany to reinforce key points and give students the opportunity to test their knowledge. Quizzes help students prepare for the 25-question; multiple-choice exam administered at the end of the course. To receive a certificate and CEUs, you must attend all eight hours of the course and attain a 70% or better score on the exam.*
