<u>TOPIC:</u> Condition Assessment of Large Diameter Cast Iron Outfall Pipes Under Piers 33 & 35 in the San Francisco Bay

SPEAKER: Darby Howard

ABSTRACT: One project that required out-of-the-box thinking was the evaluation of the condition of the 70-year-old pipelines carrying treated effluent water into San Francisco Bay. After several engineering firms reviewed the project, they felt an assessment of the pipes was not possible and therefore recommended a prohibitively expensive replacement of the pipes. However, with novel and unconventional techniques, the engineers of JDH Corrosion Consultants were able to accurately determine the degree of corrosion on both the inside of the pipes as well as on the exterior of the pipelines and as a result were able to save the City of San Francisco millions of dollars. Lining, coating and cathodic protection will be discussed during the presentation.
