DID YOU KNOW?

- Some air conditioning and heating problems can DOUBLE operating costs without reducing comfort.
- Up to 80% of all air conditioning and heat pump compressor failures could be eliminated if the problems that lead to the failure were corrected in a timely manner
- A "freon" (refrigerant) undercharge of only 10% can increase operating costs by almost 20%
- "Freon" (refrigerant) should never need to be replaced. If it must be added every year, there is an expensive leak that should be repaired.
- A dirty evaporator, condenser and blower could increase air conditioning or heat pump electrical usage by 50% or more.
- Just a 100th of an inch of dirt or film on an evaporator coil can reduce its efficiency 5%.
- Un-repaired small problems can lead to very expensive repairs.
- Depending on the current condition of your equipment this service may pay for itself several times over in energy savings alone.
- Annual safety checks can eliminate dangerous problems.
- A large number of air flow problems are a result of dirty filters which are not changed on a regular basis. Filters should be cleaned or replaced once a month. Dirty filters put unnecessary strain on your heating and air conditioning system, which could result in part failure. This could cause higher utility bills or leave you in a no heat situation.

According to studies conducted by the Louisiana Cooperative Extension Service and Gulf States Utility Company, you can **SAVE up to \$30 a month on your utility bill** by making sure that your air conditioning system is cleaned and serviced regularly.

Heating Season Checklist:

- 1. verify thermostat settings and operation
- 2. clean, adjust and test safety controls
- 3. verify gas furnace operations and gas pressures
- 4. lubricate motors and pumps
- 5. replace customer supplied air filters
- 6. check heat exchanger for cracks or holes
- verify humidifier function and set humidistat control (if applicable)
- 8. check and verify total efficiency and performance

Cooling Season Checklist:

- 1. verify thermostat settings and operation
- 2. check refrigerant levels, refrigerant is sold by the pound at market price
- 3. verify voltage and amperage to motors
- 4. check temperature split across evaporator coil
- 5. replace customer supplied air filters
- 6. check wiring and all controls
- 7. clean condenser coil, flush trap and drain lines
- 8. check cooling system efficiency and operation

Alisea HVAC, Inc. offers 24 hour emergency service response time during the heating season and 48 hour response time during the cooling season. Normal business hours are Monday through Friday 7 a.m. to 4 p.m. Evenings and weekends are billed at overtime rates. Holidays are billed at double time.

Contract customers receive a 10% discount on parts and labor. All repairs are billed on a time and materials basis. Payment is due at completion of repair. Alisea HVAC shall not be liable for any loss resulting from a delay, failure to discover a condition requiring replacement or repair or as a result of any work under this agreement, including but not limited to hotels or high utility bills.

This agreement is for one year from the effective date and will continue without interruption in service based upon renewal date unless cancelled in writing by either party or non-payment.
