Commodity Trade Finance

One of the most crucial aspects of international trade finance is determining the payment method agreed upon by the importer and exporter. The exporter typically wants to receive payment as soon as possible, while the importer aims to mitigate risks associated with the supply and delay payment. Trade finance resolves this conflict by providing funding and addressing the needs of both parties.

Investment Process

We employ an active investment approach, carefully selecting high-quality trade finance transactions across different asset classes. Our focus is global, with a particular emphasis on Europe, CIS, Africa, and Asia. We provide funding for a variety of structured debt structures and configurations.
