

There are two other bills in the House (HB 2238 & HB 274) that read exactly as the same Senate Bill did before the amendment. Its attached to this newsletter.

Basically, to lower the number of intact females from 11 to 5 and added for "Breed or Conformation shows" (see attached)

Background: - The original bill "1451" was passed into law in 2011/12 and after ten years the 2020/2021 Sunset Commission recommended the Licensed Breeders Program is not necessary to protect the public and should be eliminated.

The 2020/2021 Sunset Commission report on pp 23-25 states, "TDLR's programs and practices were recently reviewed as part of its most recent "sunset process", which regularly evaluates state agencies and programs to see if they are still relevant. The Sunset Advisory Commission's June 2020 Staff Report recommended that the Licensed Breeders Program is not necessary to protect the public and should be eliminated."

"The Licensed Breeder Program fails to meet expectations...Throughout its implementation, the actual number of licensees has average between 150 -170...revenues do not cover administrative cost as required by law." "A 2018 Agency fee study found the program had a 38% cost overrun."

Unfortunately former Senator Eddie Lucio author of HB 1451 was sitting on the Sunset Commission and severed it which brings us to HB 2238, HB 274 and SB 876. All are identical in wording to reduce the number of intact female animals from 11 to 5 and remove "and who sells or exchanges or offers to sell or exchange, not few than 20 animals in a calendar year."

Have been told there is "big" money(my guess Humane Society of the U.S.) behind the push to get this law back on the books with the lower number of intact females. We know from previous writings their intent is to keep lowering the number until it's only one and then there will probably be a push to "mandatory s/n" all dogs/cats.
