

Location: Peddlers Pavilion in Seacrest Beach

When: Every Sunday 9:00am-1:00pm

Cost: \$200 Annual Membership Fee / \$75 Daily Booth Rental.

### Setup Time:

The set-up time will be no later than 7:30 AM. Set up time begins at 7:00 AM (and not prior) and no later than 7:30AM.

Vendors are required to stay until closing. Vendors who sell out early must keep their booth set up and post a sign informing customers that they have sold-out.

**Sanitation:** Food vendors are required to have a hand washing station in their tent, that consists of a jug of water, a trash can, hand soap, sanitizer and paper towels. Food must always be covered, kept at the correct temperature to ensure the safety of the food. You must have a thermometer to check your food temperature during markets if you sell temperature-controlled foods. All food vendors must have prior authorization before sampling products.

### Cleanup:

Vendors provide garbage cans for consumers. Booths must stay clean. Vendors are required to clean up their tent and surrounding areas if trash is visible. Please help keep our market neat and clean which will ensure longevity at this amazing location!

# Pricing and quality of produce/products:

Pricing of goods sold at the Market is solely up to the vendor. You are required to collect applicable taxes on tangible property that is sold at the market. It is not managements responsibility to disclose your income or tax liability, that is strictly up to each individual vendor.

# Taxes, Insurance, Licenses, Permits and special requirements:

Tax collection and payment is solely the responsibility of the vendor. You are responsible for following all state and city laws when selling or producing any products. This includes following cottage food or commercial food permits and licenses. It is

required that you obtain a Farmers Market Vendor Liability policy of at least \$1,000,000 yearly and add Emerald Coast Markets and Events/Peddlers Pavilion as the holder. It is also a requirement before being allowed to set up or being accepted into the market, that you submit your SERV Safe Certificate, and Commercial Kitchen Agreement. Without the above-listed requirements, you will be denied access to the acceptance phase.
