I represent that I am eligible to enter and/or participate under the rules of the Competition, and every horse I am entering is eligible as entered. This document waives important legal rights. Read it carefully before signing. I AGREE in consideration for my participation in this competition ("Competition"), which is managed by Clip-Clop Farm LLC, BREC's Farr Park Equestrian Center, and Hitch Stables to the following: I AGREE the construction and application of Clip-Clop Farm, LLC, BREC's Farr Park Equestrian Center, Hitch Stables rules are governed by the laws of the State of Mississippi and Louisiana, and any action instituted against Clip-Clop Farm, LLC, BREC's Farr Park Equestrian Center and Hitch Stables must be filed in the State of Mississippi and Louisiana. I AGREE that Clip-Clop Farm, LLC, BREC's Farr Park Equestrian Center, Hitch Stables as used herein includes Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, and volunteers. I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, handler, lessee, owner, agent, coach, trainer, or as parent of guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including but not limited to broken bones, head injuries, trauma, pain, suffering, or death. ("Harm").
