I AGREE in consideration for my participation in this competition ("Competition"), which is managed by Clip-Clop Farm LLC & Pearl County Fairgrounds to the following: I AGREE the construction and application of Clip-Clop Farm, LLC & Pearl River County Fairgrounds rules are governed by the laws of the State of Mississippi, and any action instituted against Clip-Clop Farm, LLC & Pearl River County Fairgrounds must be filed in the State of Mississippi. I AGREE that Clip-Clop Farm, LLC & Pearl River County Fairgrounds as used herein includes Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, and volunteers. I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, handler, lessee, owner, agent, coach, trainer, or as parent of guardian of a junior exhibitor.
