I AGREE in consideration for my participation in this competition ("Competition"), which is managed by Clip-Clop Farm LLC & Pearl County Fairgrounds to the following: I AGREE the construction and application of Clip-Clop Farm, LLC & Pearl River County Fairgrounds rules are governed by the laws of the State of Mississippi, and any action instituted against Clip-Clop Farm, LLC & Pearl River County Fairgrounds must be filed in the State of Mississippi. I AGREE that Clip-Clop Farm, LLC & Pearl River County Fairgrounds as used herein includes Competition Management, as well as all of their officials, officers, directors, employees, agents, personnel, and volunteers. I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, handler, lessee, owner, agent, coach, trainer, or as parent of guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherit dangerous risks of accident, loss, and serious bodily injury including but not limited to broken bones, head injuries, trauma, pain, suffering, or death.
