The Seller guarantees that the puppy is in good health at the time of sale. The puppy will not be released to the Buyer until it has received a comprehensive veterinary examination, initial vaccinations, and deworming, and is certified as healthy by a licensed veterinarian.

The Puppy Packet provided at the time of sale will include:

- A copy of both parents' registration papers
- Parent's health test
- The puppy's vaccination and deworming records
- A NuVet supplement sample
- A sample of the puppy's current food

The Buyer agrees to have the puppy spayed or neutered by the age of 8 months and will provide proof to the Seller within 30 days of the procedure. Failure to comply will void this health guarantee and may result in legal action to enforce the contract terms.

The Seller guarantees the puppy against known congenital defects affecting the Poodle and Cavalier King Charles Spaniel breeds (e.g., Mitral Valve Disease (MVD), Glaucoma, Syringomyelia, Chiari Malformation and Hereditary Cataracts) for 24 months from the date of birth. If a congenital defect as listed above is diagnosed, the Buyer must provide documentation from two unassociated, licensed veterinarians confirming the diagnosis.

If the puppy is diagnosed with a congenital defect covered by this warranty, the Buyer is entitled to a replacement puppy of comparable value from the next available litter. The Seller reserves the right to request a necropsy in the case of the puppy's death. **No monetary refunds will be provided; only a replacement puppy will be offered.**

Conditions for Replacement:

1. **Notification:** Written notification must be provided to the Seller of the diagnosis, along with two unassociated veterinary reports confirming the congenital defect.
2. **Ownership:** The Buyer must be the original owner of the puppy.

3. **Veterinary Care:** The Buyer must maintain routine veterinary care, including vaccinations and parasite control, and provide records to the Seller upon request. Failure to do so voids this guarantee.
4. **Return of Puppy:** If requested by the Seller, the Buyer must return the puppy to the Seller at the Buyer's expense in order to complete replacement.

ADDITIONAL TERMS AND CONDITIONS:

1. **Limitation of Liability:**
The Seller is not responsible for any veterinary costs incurred by the Buyer once the puppy leaves the Seller's premises, except as outlined in the health guarantee. The Seller is not liable for any accidental injury, illness, or disease contracted once the puppy leaves the Seller's care.
2. **Size, Color, Temperament, and Coat:**
The Seller does not guarantee the size, color, temperament, or coat type of the puppy, as these traits may vary with hybrid breeds.
3. **Behavioral Training and Care Requirements:**
The Buyer agrees to provide adequate training, socialization, and care for the puppy. The Seller is not liable for behavioral issues or any damage or injury caused by the puppy once it is in the Buyer's possession.
4. **Return Policy:**
If, at any time, the Buyer is unable to care for the puppy, they must contact the Seller to discuss rehoming options. The Seller retains the right of first refusal to reclaim the puppy.
No refunds will be given if the Buyer returns the puppy for any reason.
5. **Jurisdiction and Venue:**
This contract is governed by the laws of the State of Washington. Any disputes arising under this contract shall be resolved in the courts located in Spokane County, Washington.

TERMS OF AGREEMENT:

The undersigned agrees to uphold all covenants of this Agreement as of the date below. This document constitutes the entire agreement between the parties and supersedes any prior agreements or representations. Any modifications to this agreement must be in writing and signed by both parties.
