

## PRIVACY POLICY

NeXus Sports Fundraising ("we," "our," or "us") is dedicated to safeguarding your privacy. This Privacy Policy details how we collect, use, disclose, and protect your information when you visit our website and utilize our services (the "Services"). Please review this policy carefully. If you do not agree with its terms, please refrain from accessing the Services.

# RIGHT TO ERASURE REQUEST FORM

You are entitled to request us to erase any personal data we hold about you under EU General Data Protection Regulation (GDPR).

We will do our best to respond promptly and in any event within one month of the following:

- Our receipt of your written request; or
- Our receipt of any further information we may ask you to provide to enable us to comply with your request, whichever happens to be later.

The information you supply in this form will only be used for the purposes of identifying the personal data you are requesting that we erase and responding to your request. You are not obliged to complete this form to make a request, but doing so will make it easier for us to process your request quickly.

# INFORMATION WE COLLECT

When you interact with us through the Services, NeXus Sports Fundraising may collect Personal Data and other information from you, as described below:

We collect Personal Data from you (including, but not limited to, your name, email address, and location) when you voluntarily provide such information. This may occur when you contact us with inquiries, respond to one of our surveys, register for access to the Services, or utilize certain features of our Services. Whenever NeXus Sports Fundraising collects Personal Data, we strive to provide a link to this Privacy Policy.

We collect this Personal Data for the purposes of delivering the Services to you, as well as for providing customer support, conducting research, and enhancing our Services. For more information on the reasons we collect your Personal Data and how we utilize it, please see the section below titled "Our Use of Personal Data and Other Information." While you are not obligated to provide any Personal Data, please be aware that withholding such information may prevent us from offering you some or all of the Services.



By voluntarily providing us with your Personal Data, you consent to our use of it in accordance with this Privacy Policy. If you submit Personal Data through the Services, you acknowledge and agree that such Personal Data may be transferred from your current location to the offices and servers of NeXus Sports Fundraising and authorized third parties located in the United States.

Non-Personal Data: When you interact with NeXus Sports Fundraising through our Services, we automatically receive and store certain non-identifiable information. This information is collected passively using various technologies and cannot be used to specifically identify you. Examples of this non-identifiable information include the type of internet browser or mobile device you are using, any website from which you arrived at our Services, your operating system, and anonymous location data (if you log in through the Platform, you may be asked to consent to our access to your location, which can be updated at any time in your device settings) ("Non-Personal Data"). NeXus Sports Fundraising may store such Non-Personal Data or include it in databases maintained by our affiliates, agents, or service providers. We may use this Non-Personal Data to enhance our Services and collect broad demographic information for aggregate analysis.

Aggregated Data: To better understand and serve our users, NeXus Sports Fundraising conducts research on customer demographics, interests, and behaviors based on the Personal Data, Non-Personal Data, and other information provided to us. This research is compiled and analyzed on a de-identified, aggregate basis, and we may share this aggregate data with our affiliates, agents, and business partners. This aggregate information does not identify you personally. We may also disclose aggregated user statistics to describe our services to current and prospective business partners and other third parties for lawful purposes.

**Location Information:** When you use our Services to organize a fundraising campaign, we may request that you provide your city or town and state of residence. Please note that other users may be able to see your city or town and state in connection with the campaign if this information is included in NeXus Sports Fundraising's Campaign Directory. We may also utilize your location information in an aggregated manner, as detailed in the "Aggregated Data" section above.

**Social Networking Integrations:** You may have the option to post your activities on our Services to your Social Networking Services when accessing content (e.g., posting on Facebook about your fundraising activities). If you choose to use this feature, your friends and followers on any enabled Social Networking Services will be able to view such activities. Please remember that the use of your information by Social Networking Services is governed by their own privacy policies, and NeXus Sports Fundraising cannot be held responsible for their practices.



Mobile Services: Our Services include features available via mobile devices, such as (i) the ability to upload content through a mobile device, (ii) browsing the Platform and Services from a mobile device, and (iii) accessing specific features via a mobile application. Standard charges, data rates, and other fees from your wireless service provider may apply when accessing the Services through a mobile device. Additionally, downloading, installing, or using certain Mobile Services may be restricted by your carrier, and not all Mobile Services may be compatible with all carriers or devices. By using our Mobile Services, you consent to receive communications regarding NeXus Sports Fundraising via SMS, MMS, text message, or other electronic means on your mobile device, and you agree to provide us with updated information if your mobile number changes or is deactivated.

**Third-Party Personal Data:** Our Services may also collect Personal Data related to third parties stored in your email and mobile device address books, including names, email addresses, and phone numbers (collectively, "Third-Party Personal Data"). We may request your permission to access such Third-Party Personal Data.

#### YOUR OPTIONS

As outlined throughout this Privacy Policy, you can explore the NeXus Sports Fundraising platform without providing any Personal Data. However, opting not to share any Personal Data may restrict your access to certain features and services.

### **EXCLUSION**

This Privacy Policy is applicable solely to Personal Data collected by NeXus Sports Fundraising through its Services. It does not cover any unsolicited information you may provide through the Services or any other means. This includes, but is not limited to, information shared in public areas of the Services, such as forums or comment sections, customer support communications, ideas for new features, or modifications to existing offerings, and other unsolicited submissions (collectively referred to as "Unsolicited Information"). You acknowledge that any Unsolicited Information becomes the intellectual property of NeXus Sports Fundraising to the fullest extent allowed by applicable law, and you agree to assign any residual rights or interests you may have in such Unsolicited Information to NeXus Sports Fundraising. All Unsolicited Information shall be treated as non-confidential, allowing NeXus Sports Fundraising to freely reproduce, use, disclose, and distribute such information to others without limitation or attribution as permitted by law.

# AGE REQUIREMENT



NeXus Sports Fundraising does not knowingly collect Personal Data from children under the age of 13. If you are under 13, please refrain from using the Services or submitting any Personal Data. We encourage parents and legal guardians to supervise their children's Internet usage and to help enforce our Privacy Policy by instructing them not to provide Personal Data on the Services without permission.
