Call to Order:

The meeting was called to order at 7:00 p.m. by Supervisor Murphy, followed by the Pledge of Allegiance to the American flag.

Board Members Present:

Motion to Approve Minutes:

- Motion by Couture, seconded by Greenleaf, to approve the minutes from the December 8, 2025, meeting.

Guest Introduction and Citizens Present:

Citizens' Concerns: Jim Strickland provide a neighbor's blithe complaint and discussed how he has been inquiring about the Bead Grant and MEC has confirmed they are approved and now waiting for the state to move forward.

Treasurer's Report:

- Kovalski commented that with Michigan Class the township has earned \$1,353.56 between all accounts from 12/29/25-1/12/26.
- Motion by Scott, seconded by Greenleaf, to accept the Treasurer's Report as presented.

Clerk's Report:

- **Clerk Scott** reported that the Clinton Township Library plans to hold a special election in May, even though there is an August election during which the library could place its millage request on the ballot. At this time, the township has heard that the library is requesting 1 mill; however, the library has not responded to requests for verification. Clerk Scott encouraged everyone to vote on May 5, 2026.

Motion Kovalski, seconded by Scott to approve, to pay \$31,318.72 for the 206 Fire bills.

Vote: 5 Yes, 0 No. **Motion passed.**

Supervisor's Report:

- Supervisor Murphy provided updates on the status of various blight complaints.

Riverside Cemetery:

- The chapel doors were painted, and the only cost incurred was for the paint, as a volunteer donated their time..
