The Clinton Township Board Meeting was called to order at 7:00 p.m. by the Supervisor and the pledge was given to the American flag. Supervisor Greenleaf, Treasurer Thompson, Trustee Couture and Trustee Murphy were present. Clerk Scott was absent.
