- Supervisor Murphy reported continued but slow progress with residents from blight complaints.
- Supervisor Murphy Frontier working to install underground fiber internet in Burwyn Hills and their equipment blew a line and leaked hydraulic fluid on residents' property. Several residences have complained to Frontier and contacted the supervisor for assistance.
