Clinton Township Board Meeting:

The Clinton Township Board Meeting was called to order at 7:00 p.m. by the Supervisor and the pledge was given to the American flag.

Supervisor Greenleaf, Clerk Scott, Treasurer Thompson, Trustee Couture and Trustee Murphy were present.

Motion Murphy 2<sup>nd</sup> Couture to accept April 8 , 2024 minutes. 5 yes 0 no Motion Passed.

Guest Introduction and Citizens present: Sean McNatt, Ed Engle, Leslie Kovalski, Sandie Brissette. Sandie talked about Dr. Douglas Frank speaking about election data at Hooligans on Wednesday, May 22, 2024 at 11 am and 6 pm.

Motion Couture 2<sup>nd</sup> Murphy to accept Treasurers report as presented. 5 yes 0 no Motion Passed.

Clerk Scott discussed receiving a letter from Par Plan that states they are out of money for grants to reimburse funds for the required security cameras. The ARPA money will be used to cover the expense instead.

Motion Murphy 2<sup>nd</sup> Couture to accept Clerks report as presented. 5 yes 0 no Motion Passed.

Motion Murphy 2<sup>nd</sup> Couture to pay \$83,086.74 101 Township 5 yes 0 no Motion Passed.

Motion Couture 2<sup>nd</sup> Murphy to pay \$43.15 in Riverside Cemetery bills 209. 5 yes 0 no Motion Passed.

Motion Scott 2<sup>nd</sup> Thompson to pay \$11,643.25 206 Fire Bills. 5 yes 0 no Motion Passes.

Discussed paying SVZ Electric \$1,700 for installing new Fire Exit signs and Smoke/Carbon Monoxide Detectors in the Township Building and security light behind building.

Motion Scott 2<sup>nd</sup> Thompson to pay SVZ for the installation of the Fire exit signs, smoke detectors and security light. 5 yes 0 no Motion Passed.

Motion Scott 2<sup>nd</sup> Thompson to approve an Amendment for Zoning for Adult Entertainment. 5 yes 0 no Motion Passed.

Motion Scott 2<sup>nd</sup> Thompson to approve the Ordinance for Adult Dancers. 5 yes 0 no Motion Passed.

Motion Scott 2<sup>nd</sup> Thompson to approve the Ordinance for Adult Entertainment. 5 yes 0 no Motion Passed.

Discussed having short summaries of the Ordinances composed by the township lawyer put in the paper instead of the full ordinance and agreed to use the Clinton Local with a total bid of \$161.50.

Discussed issues the Township was having with the Clinton Local Newspaper. These issues include wording changes that are being made to the minutes previously sent in, as well as the fact that the Tecumseh Herald charges less to post the same minutes.

Motion Scott 2<sup>nd</sup> Thompson to send minutes to the Tecumseh Herald. 4 yes 1 no with Murphy voting no Motion Passed.

Discussed the Bid for Hogan Hwy and Murphy Hwy. All agreed that Hogan Hwy is the responsibility of the county. Having Murphy Hwy done this year for \$51,273.75 instead of 2025-2026 will save the Township about \$11,000. There are funds left in the budget for the roads and \$11,481.36 from the ARPA funds can be used to cover the expense

Motion Thompson 2<sup>nd</sup> Scott to pay \$51,273.75 for repairs on Murphy Hwy. 5 yes 0 no Motion Passed.

Discussed using ARPA funds to have the doors on the shed repaired.

Discussed using ARPA funds to purchase shelving and storage tubs for the basement.

Motion Murphy 2<sup>nd</sup> Couture to adjourn at 7:37 pm 5 yes 0 no Motion Passed.
