Citizens' concerns:

Strickland, Casper, and McKelvie raised concerns regarding blight within the township. They recommended that the township take action to address these issues or consider hiring and ordinance enforcement officer to manage the situation.

McKelvie voiced concerns regarding the lack of high-speed internet access for his property, as well as those of Strickland and Casper. He emphasized that the township should take action to address this issue. The board noted that a special program had been available over a year ago, which was advertised in the local newspaper, but has since expired. The township will investigate whether any current options are available.
