Discuss feedback from the Advisory Board meeting and how it can work into the 3 yr plan:

- Discuss college/adult school ESL faculty discussion group
 - Develop a common understanding of ESL skill levels for appropriate placement:
 - Discussed starting this conversation utilizing the 2024 FH 403A/B & DA COUN cohorts
 - what students came to my classes from this collaboration, and specifically for the public health certificate.
 - We can get this to Amy from the cohort doc from FUHSD/PAAS
 - We discuss this cohort at the college data meeting on the 10/16
 - Get feedback from Amy & Christian on the success rate of the students:
 - Writing examples etc. .
 - Once we have that assessment- set a time to meet
 - If we are designating high level ESL as "language ready" how are we identifying if a student actually is?
 - What part of "language" seems to be the barrier: reading, writing, listening, speaking, or digital/tech?
 - GSP: How accurate is this for placing AS students?
 - Make FH GSP mandatory for AS students in our pathways.
 - What tool do we use for helping identify language readiness at DA?
 - PAAS took placement / FUHSD did not- use this as a data point to see if there is a difference in student outcomes?
 - Caveat is that if they do not do well, they could be stuck with that placement?

- o Foothill's GSP is flexible
- Access/navigation to GSP is a barrier
 - Have students go to the Sunnyvale Center for orientation and do the GSP
- GSP Sessions: Two College info sessions for students who are on a waitlist for a test:
 - o Coordinate the AS testing for before the quarter starts
 - First week of quarter to
 - Dec 7th at Sunnyvale Center (Tentative)
- Can the CASAS test be an indicator of "Language Ready? Other ideas?
- To help get "Language ready" Add DA: 200 / FH 410. Bridge courses to the pathway
- Eventually, ESL instructors form a community of practice to map curriculum between Adult School & Colleges
