Outcomes + Next Steps

- 58 participants joined representing 14 of the 16 Bay Region AE Consortia
- Updates were provided and next steps discussed related to the two strongest interests of this group to date: Co-investing in local data related work and participating in the Statewide AE Data LaunchBoard Tab pilot
- The group ratified Piedmont Unified School District as the Fiscal Agent for the local data effort (\$100K) - a huge thank you to Michael Brady and Shemila Johnson for your support on this front! <u>Participating Consortia</u> can expect to hear from PUSD regarding an invoice for your contributory amount
- All were asked to use the Scope of Work handout above to enlist strong candidates for the near future opening of an RFA for a local Data Consultant(s) to lead that work on our behalf
- Rock provided an overview of the Strong Workforce Program (SWP), with specific emphasis on the Regional Planning process
- Randy Tillery proposed we consider investing in Career Pathway collaboration since a)
 there is general consensus it makes little sense to develop specific career
 pathways independently across the region and b) to take advantage of the
 learning curve of the Career Advancement Academies and a \$75K technical
 assistance grant to help jumpstart this work
- There was definite interest in having a loud, participatory voice in the SWP Regional
 Planning process. To that end we identified and prioritized the following regional
 work initiatives (notes available here) we'd like to bring forward to the 10/21
 and 12/2 SWP Regional Planning meetings to assess broader interest, as follows:
- Data
- Industry Engagement
- Career Pathways

- Student Support Services
- Non-Credit / Curriculum
- There was a desire to have 2 representatives (1 AE and 1 Community College) from each Consortia participate in the 10/21 and 12/2 meetings with each Consortia agreeing on who those folks would be. See 10/21 meeting details below (12/2 details to follow once we know them:-)
- We did not get time to discuss an organizational framework, but we did agree that 1-2
 additional community college subcommittee members would be helpful.
 Thankfully, Thatcher Weldon and Mark Wade Lieu stepped forward to play that
 role! I will be in touch soon regarding a next subcommittee call
- It was shared that the work of this group will be presented at the upcoming Adult Ed Summit including participation in a legislative briefing following the proceedings. Bob Harper and Jacques LaCour (our mighty subcommittee members) will be presenting on behalf of the group much appreciation to Bob and Jacques!
 Lastly, we agreed it would behoove us to come together again before the SWP Regional Plan is finalized (deadline 1/31/17). To that end the subcomittee will vet dates from mid-Dec to mid-Jan in hopes of finding one that will work for a CALL. A save-the-date is forthcoming
