- Targets in Metrics Section
  - Activities and Objectives important
  - Curriculum Alignment ready, all editing will need to be finished soon
  - Executive Summary findings taken from last self-assessment
  - Need to reassess numbers with discrepancies. For instance: ASE 2459 (100%)
  - Launchboard numbers must align with CAEP. Data Group will investigate and report to state. Coding too often misrepresenting class numbers. Each metric has indicator number. Needs to be broken down by Adult Schools and Community Colleges.
  - (D in Three Year Plan Draft) NOVA will auto-populate numbers. Need to add note to explain discrepancy.

- 4 Barriers in Metrics. Must choose one. Agreed on **English Language Learner**.
- Activities/Outcomes now added optional metrics. Choose **Participants with Educational Functioning Levels Gains ESL** and **Participants with Transition to Postsecondary** (credit college).
- For Transition, choose credit one and skip Success & Employment/Earnings.
- All schools do "All", but can put zero in progress if doesn't pertain to you
- Karen/Julie: need data and targets form overreaching works (targets may change, but auto population does not so any changes need to be noted). Be conservative in Enrollment/Student Growth due to pandemic so 2% will be entered in NOVA (if you want to change your number please notify Jenée.
- Annual Plan now due in September, but as it is a living document it should be incorporated on a daily basis
- Colleges do not use Precision Campus to track numbers (only Adult Schools do), so coding may be off
- Jenée will look into 0% entry for Foothill under Member Spending Targets
