What is work for workgroups?

Need specific tasks/focus – current staff already doing student support. Combine CTE & ESL?

- Thomas suggested work groups should stay at program level, addressing certain issues only as they arise, Randy advised using student reps, and Julie mentioned considering outlook and wages.
- Delegate, rather than micromanage task force.
