Agency Updates:

MVLA:

PAAS: 10 ESL dual enrollment students at DeAnza

FUHSD: Winter Quarter: 25 dual enrollment students (3 dual enrollment students at De Anza reached out for support with purchasing textbooks/class materials and were approved for financial aid). HSD/GED/Advanced ESL visits to discuss Career and College Event and Dual Enrollment for Spring, 2023. 14 diploma and 10 parent ed, 1 ELS. Thank you to Felisa, Joselyn and Vins for supporting our students

DA: Felisa working with financial aid to offer book vouchers for our dual enrollment. Felisa can estimate how much each student receives. If the student does not use their full book voucher funds- it goes back into the general fund.

- Financial Aid for Dual Enrollment Students: When you send a request for financial aid for a student please include the following: Student Name, CWID, Email, Amount Requested Per Student (\$50-\$500 based on student need). The adult schools should ask their students to let them know if they need financial assistance before the start of the quarter to ensure that the student has the required materials ahead of time.
 Requirement: dually enrolled and ans worked with transition advisor/counselor to identify financial need
 - Barrier: On some occasions the bookstore/teacher does not post the required materials
 - Can we ask instructors for class syllabus in advance to share with the tutor and for us to view what is required of the students including materials needed? We can try but sometimes it is not available ahead of time? Can we ask the instructor for the course materials required ahead of time? Foothill: Yes, you can ask but there are multiple factors why it can be happening-no structure that requires this. De Anza: Some instructors are more on top of this than others. If you know that a student needs help with materials (ex: \$200 general estimation). We can let students know that we can support them if they need help paying for a book. DT will share survey with Gina & Sripriya
 - Does Foothill offer financial aid support for dual enrollment students too? Janie can look into this and figure out what supports are available.
