### College Idea

- → Create mirrored NC Medical Terminology (can have tutor wrap around services)
  - ◆ Students in this class can also be referred to the AS CNA progeam if they are interested.
- → NC 403B: ESL Writing Bridge
  - ◆ Taken along with another class to contextualize it with
  - ◆ Issues- time- it would be an extra 3 hrs/wk. Or it can be split between two quarters- so only 1.5 hrs/week
  - ◆ Is this class intended to to place students in an ESL pathway? If so, can the skills learned help our students succeed in CTE pathways.
- → ESL for Healthcare (Amy Sarver to write this-roll out Summer 2025)
  - One idea: Make this a bridge class: have this be a more applied class with heavier tech wring: next level to the AS med term classes. This can give students extra writing support.
  - What is the intended audience: AS CNA, MA,
  - ◆ Make it more genres- then make sections of it more specific to certain HC fields
- → AHS 51: turn this into a mirrored noncredt course
