**MOTION TO MODIFY RECEIVER'S  
NOTICE AND CLAIM PROTOCOLS**

COMES NOW, the Receiver, Resolve Financial Group, Inc., through its President, Maggie Lyons, and moves this Court to modify the proposed Notice and Claim Protocols, which the Receiver proposed in its Joint Motion for Dissolution of Idaho Corporations and Appointment of Receiver ("Joint Motion"). In support thereof, Movant states as follows:

1. The proposed Notice and Claim Protocols are as follows: In general, the process entails publishing notice, as set forth in this Joint Motion, in various newspapers and publications. In addition, notice and the proof of claim forms were proposed to be served on all known shareholders, and with service of process on various regulatory and federal entities. The Proposed Notice Recipients are set forth within this Joint Motion. In addition, the originally filed Proposed Notice Recipients, the original Publication Notice, and original Proof of Claim Form, are all attached to this Joint Motion as Exhibits A, B and C, respectively.

2. An analysis by the Receiver has determined that notice and the method of submitting a proof of claim can be streamlined by the use of the following website: [www.onstinereceivership.com](http://www.onstinereceivership.com). The website will contain the revised published notice to local publications, specialized industry publications, and an outreach to brokers and market participants, which notice is geared to be more effective, and less expensive than the proposed notice that has been approved by the Court. In addition, Receiver proposes sending a one-page letter to known shareholders to refine the mailing list based on letters returned as undeliverable.

3. Accordingly, the Receiver proposes that notice be made by publication two times each, and thirty (30) days apart in the following:
