

## 2023 Fayette County Republican Convention

### Resolution Protecting Georgians Rights to Free, Honest, and Fair Elections

WHEREAS, All Georgians have a First Amendment Right to Free, Honest, and Fair Elections; and

WHEREAS, Use of DOMINION, ERIC, GARVIS, POLL PAD, KONNECH, and KNOW LINK in Georgia exposes Georgia Electors personal information (address, birth date, social security number, e-mail address, driver's license number, etc.) by being stored by out-of-state and out-of-country parties in cloud environments which violates Georgia Code Sections 21-2-211 (a) and (b); and

WHEREAS, Voter Registration Rolls in Georgia are inflated with persons not qualified to vote; such as, dead people, people who do not reside in the precincts where they are registered, phantom or imaginary people, and the number of registered voters exceeds the number of people qualified to vote in a given jurisdiction; and

WHEREAS, All Computers Can Be Hacked and their Data Manipulated; including, Voting Machine Computers, especially if these computers contain WIFI modems, Bluetooth modems, or other types of connectivity; further, there is ample evidence that Poll Pads, Ballot Marking Devices, and Ballot Scanners are easily hacked; and that the Voting Data has been manipulated remotely; and

WHEREAS, there is evidence of Real Ballots Voted being electronically Deleted and Fraudulent Ballots being added by both electronic and manual means sufficient to alter the results of elections, which has resulted in the number of Ballots Voted not matching the number of Ballots Counted in numerous Precincts; and

WHEREAS, Elections utilizing Voting Machines are more costly than voting by hand and is a waste of the Taxpayers limited resources.

NOW, THEREFORE BE IT RESOLVED THAT the Fayette County Republican Party calls for all types of Computer Voting Machines to be banned in Georgia. That No Computer or Electronic Device or Machine of any kind shall have any access to the Ballots. That all Elections in Georgia shall be conducted on One Election Day, with Pre-Printed Security Paper Ballots, that are Hand Marked and Hand Counted at their Precinct of Residence; or by a secure Absentee process. That Absentee Ballots shall require unique bar codes and alphanumeric accountability numbers on individual absentee ballots (SB 226) and shall be Returned only to the Election Office before Election Day, and shall be Counted by Hand at the Election Office on Election Day only.

BE IT FURTHER RESOLVED that the Fayette County Republican Party calls on the General Assembly to draft and adopt legislation making any Election Fraud a FELONY in Georgia.

BE IT FURTHER RESOLVED that the secretary of the Fayette County Republican Party and/or Convention Secretary is directed to transmit a copy of this resolution to the Governor, Lieutenant Governor, President Pro Tempore, Speaker of the House, Speaker Pro Tempore, Third and Thirteenth District Republican Leadership, and the State of Georgia Republican Party to encourage them to affirm, adopt, and enact this resolution by law, policies, and/or adoption of this resolution.
