I _____ (Contract Purchaser/Mare Owner) hereby agrees on this _____ day of _____ 20____, to breed the mare named below to the stallion **Blue Light District** for the **2025** season subject to the following conditions and fees:

CONTRACT ACCEPTANCE:

1. The contract must be completed in full and returned to the address above.
2. A minimum non-refundable stud fee of \$1,500 USD is required, with a deposit of \$750 due upon submission of the Stallion Service Contract to secure the agreement. The full amount must be paid prior to breeding.

EARLY BOOKING STUD FEE of \$1,200 MUST BE PAID IN FULL at the submission of the Stallion Service Contract for Blue Light District.

3. Copy of mare's registration papers is required with submission of contract.

4. This contract is between the contract purchaser/mare owner and is not transferable to another party via sale of contract or sale of mare unless approved by stallion owner.

IT IS TO BE NOTED:

BREEDING SEASON AND PREGNANCY REPORTS:

1. The breeding season for the North American Continent is defined as February 1st through July 15th of each year. (see calendar) The decision to breed any mare after July 15th will be at the sole discretion of Skye Anderson. Breeding dates and pregnancy status **MUST** be reported to Skye Anderson no later than August 15 of the breeding year. Failure to report the breeding results will result in the mare not being listed on the breeding report and a late fee, per breed registry, will apply to add a mare that is in foal. **EMBRYO**

TRANSFERS:

If an **embryo transfer** is performed **and** multiple embryos are retrieved and implanted you must notify Skye Anderson **immediately**. If multiple embryos survive, a chute/booking fee and a stallion breeding fee will be due and payable prior to September 30th of the breeding year.

CONTRACT FEE: This contract is for ONE stud fee- \$1,500 (does not include chute, collection, or shipping)

EARLY BOOKING:\$1,200

SHIPPED SEMEN: Cooled semen: \$400

ONSITE BREEDING: \$500 plus board

IN THE CASE OF SHIPPED SEMEN, ALL FEES ARE DUE BEFORE THE FIRST SHIPMENT OF SEMEN.

1. **Cooled Semen for USA:** Mare owner or veterinarian must request semen at least 24 hours in advance, preferably 48 hours.
2. Cancellation or confirmation must be made by 8:00 a.m. central standard time on collection day.
Note: No guarantee is made as to availability of semen for shipment on any given day. Mares on the ranch will receive priority, then transit mares, AND THEN shipped semen mares. Foal heat mares will only receive semen if excess semen is available.
3. Skye Anderson or Black Rock Ranch is not responsible for the untimely delivery or condition of the cooled-shipped semen, as we have no control of the shipment after it leaves our custody. Should there be a delivery delay of semen via FedEx or air carrier the mare owner will only be entitled to the amount refunded by FedEx. Weather delays and/or natural disasters are excluded by FedEx and air carriers as consideration for refunds.
4. Mare owner is responsible for return of Equitainer within 48 hours by normal (priority overnight) on UPS or Federal Express. Equitainer not received within 5 days will be invoiced to you at replacement cost by Garner Equine.

LIVE FOAL GUARANTEE:

1. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal, which stands and nurses without assistance. If the foal is born dead, return privileges shall apply only if Skye Anderson is notified within seven (7) days thereof and receives a veterinarian's statement confirming death and return privileges shall apply only to the next normal breeding period.
2. Mare owners must provide information on the mare's cycle and ovulation, as well as confirmation of pregnancy by ultrasound starting at 14 days post ovulation following thru to 45 days of pregnancy. Failure to do so will void live foal guarantee.

REBreed OPTIONS:

1. If the mare miscarries, proves barren after being checked in foal, or fails to conceive during the normal breeding season, we agree to breed said mare again during the following year's breeding season only unless otherwise approved by Skye Anderson. There will be a charge for "re-breed" service Expenses (collection, shipping, etc.).

MARE SUBSTITUTIONS:

1. At the discretion of Skye Anderson, a substitute mare may be allowed if the original mare is deemed unfit for breeding. The mare owner must request a substitution form and submit for approval before breeding the substitute mare. There is a \$150 charge to substitute a mare. Skye Anderson must approve the substitution prior to her being bred.

MARE OWNER RESPONSIBILITIES:

1. Mare Owner is responsible for obtaining proper care and maintenance of their mare under the direction of a qualified licensed Veterinarian with Equine Reproduction expertise with the shared goal of producing a live, healthy foal.
2. Mare Owner is responsible for completing and sending to AQHA, APHA or any other applicable breed organization any paperwork they require related to use of transported semen. Mare owners are responsible for blood typing or DNA testing their mare as per AQHA rule 209 or APHA rule RG-165. 3. Embryo enrollment forms for the mare are the responsibility of the mare owner.
4. FAILURE TO NOTIFY SKYE ANDERSON OF YOUR MARE'S PREGNANCY STATUS BY AUG 15TH, COULD RESULT IN HER BEING LEFT OFF OF THE BREEDER'S REPORT. FEES FOR FILING A LATE OR AMENDED REPORT WOULD HAVE TO BE PAID PRIOR TO THE CORRECTION BEING MADE WITH THE APPROPRIATE ASSOCIATION AND A BREEDER'S CERTIFICATE ISSUED.

5. MARE OWNER MUST PROVIDE BREEDING DATES TO SKYE ANDERSON FOR BREEDING REPORT.

BREEDERS CERTIFICATE:

1. **This contract is only valid for one (1) breeders certificate.** Multiple embryos will require separate

contracts and fees. A “breeders’ certificate” will be issued and/or released on-line for the live foal conceived by the mating when stallion fees and all other expenses have been paid in full. Mare Owner must notify Skye Anderson that a live foal has been produced.

LIABILITIES:

1. Neither Skye Anderson nor any person associated with Blue Light District breeding team shall be liable for the death, sickness, and/or accident to the mare and/or foal; similarly, neither the mare owner nor any other person associated with the mare shall be liable for the death, sickness and/or accident to the stallion.
2. The parties further agree that should the Stallion die or become unfit for service for ANY reason or if the Mare should die or become unfit to breed, then this contract shall become null and void and both parties are relieved of any further obligation hereunder.
3. The parties acknowledge that this agreement is made within the State of Montana and shall be construed and enforced under the laws of the State of Montana. Should any dispute arise as a result, the laws of the State of Montana shall apply and the venue shall be Lincoln County.
4. This contract shall be binding upon the parties hereto, upon execution hereof and the same may not be altered or amended, except by written mutual consent of the parties hereto.

Shipped Semen Protocol

The key to breeding your mare with transported cooled semen is very careful planning, management and coordination.

The first day of breeding season will be February 1, 2025 and will conclude on July 15, 2025.

Schedule: 3 days a week, Monday, Wednesday, Friday Must have 24 hour notice before collection

IMPORTANT – BEFORE THE FIRST SHIPMENT

- [Full breeding fee must be paid before ordering semen.](#)
- Fully executed contract must be on file prior to ordering semen.
- **NO SEMEN WILL BE SHIPPED UNLESS PAID IN ADVANCE**
- Shipping information to have available when you place an order:
 1. Physical address to receive shipment, telephone number and email address for notification
 2. Stallion name, mare name and mare’s registration number
 3. Good contact name, phone number, and mare owner’s address

SEMEN ORDERS AND SHIPMENTS

- Do not place orders on the answering machine.
- **To order semen please contact: Hanah Greene:208-691-3915 or Andy:208-755-0755**
- Availability of semen on any given day is **not guaranteed**.
- **One** dose of semen will be sent in each shipment.
- The priority for semen will be as follows:
 1. Ranch mares
 2. Transit mares
 3. Shipped semen mares. Of the shipped semen mares, all mares that are not foal heat mares will have priority over foal heat mares. We will prioritize all mares.
- **IMPORTANT** - Requests for shipped cooled semen must be made **at least 24 hours in advance before collection**. **To receive Monday shipment, you must contact the office by noon on the**

previous Saturday.

- Confirmation/Cancellation of a semen order must be made **by 8am** Central standard time the **day of collection.**
- Use an experienced competent mare management facility. Mares should be on a regular teasing and palpation/ultrasound examination schedule. We request that you palpate mares to determine if they have ovulated in a timely manner or if you need more semen.
- **Confirmation of pregnancy by ultrasound starting at 14 days post ovulation following thru to 45 days of pregnancy is required to maintain the live foal guarantee. Failure to provide pregnancy status will result in mare not being included on the breeding report.**
- Embryo transfer: If more than one embryo is produced and transferred, Cassy Davis must be notified within 48 hours of the embryo transfer. A stallion service fee is due for each pregnancy.
