The final payment date is _____ and the final payment amount due is _____. No interest is accessed during the agreed 60-day layaway time period.

_____ Payments are to be received on or before the dates listed above. If payments are more than **2 days late**, the buyer will be charged a **late fee of \$20.00**.

_____ If payments are more than **7 days late**, Gunny's Weapons Center, LLC may cancel the layaway, and the buyer will **lose** the **30% deposit** and **any fees** associated with this agreement.

_____ All layaways must be picked up by the final payment date before **7 p.m.** The Buyer listed in this agreement must complete the pickup. The firearm will not be released to anyone other than the **Buyer** listed in the agreement. No partial pickups are allowed.

_____ No price adjustments will be allowed. The Buyer or Gunny's Weapons Center, LLC will not change the price agreed upon on the date of the sell/agreement.

_____ Online layaway buyers must follow the same rules as any over-the-counter sale; loss of deposit and late fees will apply.

_____ All layaways will be paid in cash, bank check or money order; a convenience fee of 3.75% will apply to all credit/debit card payments.

_____ The CBI background check will be conducted on the date of pickup. The CBI background check fee is **\$25.00**, and must be paid in **cash**. Should the buyer fail the CBI background check the buyer would be reimbursed all monies **minus any late fees assessed** during this agreement.

_____ CBI background checks do not apply to online sales (outside the State of Colorado), as the buyer must use a State Licensed FFL Dealer (within his/her own State) to complete the purchase. All online Buyers must be sure of their **Own** background, as Gunny's Weapons Center, LLC **Will Not** reimburse out of State buyers any monies after the firearm has been mailed to the State Licensed FFL Dealer within his or her own State. The background check will be completed by the buyer's State Licensed FFL Dealer (of the buyer's own choice), and that State Licensed FFL Dealer is responsible for releasing or not releasing the firearm to the buyer based on the background results from within his/her own State. Once the buyer's chosen State Licensed FFL Dealer has possession of the firearm, the buyer must abide by the State Licensed FFL Dealer's policies, procedures, and State Laws should the buyer fail the background check. Gunny's Weapons Center, LLC **Will Not** retake possession of a firearm based on the failure of any out of State background checks.

_____ Online Buyers: the buyer will pay for Shipping. The following fees apply: **pistols, \$30.00 (each); long guns, \$40.00 (each)**. This amount will be included in the layaway total.
