YOU MAY BE ABLE TO DISCHARGE A FINANCIAL OBLIGATION THROUGH ALTERNATIVE MEANS IF THE COURT FINDS THAT YOU HAVE THE INABILITY TO PAY YOUR OBLIGATIONS.

1. This letter is furnished as a courtesy to assist you in disposing of the charge(s) filed against you. The Judge cannot discuss the merits of a pending judicial proceeding outside of court.
2. **YOU MUST ENTER AN APPEARANCE WITHIN TEN (10) DAYS from the date of your citation. An appearance in court is only by filing the proper documents with the court by certified mail, fax, email, in person or by your attorney.** If you fail to respond to the charge(s) within the 10 days, additional fees and charge(s) may be filed against you for failure to appear and warrant(s) issued for your arrest. A juvenile who fails to appear by the time and date on the citation may have their license suspended as required by law. **To personally appear in court, contact the court to schedule your court date.**
3. If You Wish to Enter a Plea of Guilty or Nolo Contendere, please, properly complete and return the reply form provided on or before your appearance date. A plea of Nolo Contendere means that you do not contest the state's charge(s) against you. The required payment for a Nolo Contendere plea is the same as that for a plea of Guilty. Either plea indicates that you agree to waive appearance before the Court for trial. Please refer to the payment schedule shown below to determine the total amount of the payment acceptable by the Court. Make your remittance by MONEY ORDER or CASHIER'S CHECK payable to the Bremond Municipal Court.
4. If You Wish to Enter a Plea of Not Guilty and desire a trial before either the Judge or a Jury, please properly complete the reply form and mail it on or before your appearance date. The Court will notify you when you MUST appear for trial and any other required procedures. You must advise the court of any and all address changes.
5. Driver's Safety Course Information: Under the laws of the State of Texas, you may be able to have ONE charge dismissed by taking a driving safety course. **HOWEVER, YOU WILL LOSE THE RIGHT IF YOU DO NOT PROVIDE WRITTEN NOTICE TO THE COURT OF YOUR DESIRE TO DO SO AND PAY ALL FEES ON OR BEFORE YOUR APPEARANCE DATE (AS SHOWN ON YOUR CITATION).** You cannot have a speeding citation dismissed if it is a violation of 25 MPH or more above the posted speed limit or if your speed is 95 MPH or more, you are ineligible if you hold a CDL license, or if you have completed a Driver's Safety Course under this option within the year immediately preceding the date of this citation you must have a valid Texas Driver's License or permit and show proof of financial responsibility at the time of the citation as required by Section 601.081. If the alleged act was committed while operating a motorcycle, a motorcycle operator training course may be taken as approved by the DPS. If you wish to use this option to have ONE charge dismissed, read and complete the reply form and return it to the Court with required fee on or before your appearance date. You will have 90 days from the date you receive the citation to complete and provide the Court with required documentation showing completion of an approved Driving Safety Course. **IF YOU MEET THE ELIGIBILITY REQUIREMENTS AS STATED ON THE DSC REPLY FORM, THEN YOU ARE RESPONSIBLE FOR COMPLETING THE COURSE, REMITTING THE COMPLETION CERTIFICATE TO THE COURT, AND SUBMITTING A CERTIFIED COPY OF YOUR DRIVING RECORD.** (Further instructions are on that form).
6. Minors: Generally, 16 years and younger are required to come to Court with their parent or guardian. For alcohol offenses, age 18-20 must appear in Court to make a plea and juveniles 17 & under must appear in Court with a parent or guardian to make a plea.
7. **Inability to Pay: IF YOU WANT THE COURT TO CONSIDER WHETHER YOU HAVE THE INABILITY TO PAY YOUR OBLIGATION AND ALLOWING YOU TO DISCHARGE YOUR OBLIGATION THROUGH ALTERNATIVE MEANS SUCH AS COMMUNITY SERVICE, YOU MUST CONTACT THE COURT TO SCHEDULE A DATE FOR YOUR COURT APPEARANCE AS INSTRUCTED IN PARAGRAPH TWO ABOVE.**

You have a right to retain an attorney to represent you. You have the right to a jury trial. You have the right to confront and cross-examine the witnesses against you. If you have insufficient resources or income to pay a fine or costs, you may appear in Court and request the Court to allow you to discharge all or part of my fine or costs by alternative means such as performing community service. If you are not a citizen of the United States of America, a plea of guilty or no contest for the offense charged may result in deportation, the exclusion from admission to this country, or the denial of naturalization under federal law. You have a right to the possession, or notice, of certain evidence upon your request and the right for a record of said possession or notice to be filed with the Court. Until the Judgement of the Court is satisfied in full, that you are obligated to notify the Court of any change in my address, telephone number, or other contact information.

Money Order or Cashier's Check in the amount of the fine(s)is enclosed (Make remittance payable to the Bremond Municipal Court, 201 S. Dallas Street, Bremond, Texas 76629).
3. I hereby: ACKNOWLEDGE that I have read the admonishment of rights, enter a plea of NOT GUILTY, WAIVE my right to a jury trial & request a trial before the Judge. The Court will advise you of your trial date at least 10 days in advance. (YOU MUST REPORT ANY CHANGE OF ADDRESS TO THIS COURT).
4. I hereby: ACKNOWLEDGE that I have read the admonishment of rights, enter a plea NOT GUILTY, and request a trial by jury. The Court will advise you of your trial date at least 10 days in advance. (YOU MUST REPORT ANY CHANGE OF ADDRESS TO THIS COURT).

Deferred Disposition Admonishment (You must do both: 1.) enter your plea by checking guilty or no contest plea and signing above and 2.) signing this section to request Deferred Disposition – this means 2 signatures are required.)

Deferred Disposition is a period of probation that is typically 60 days. Upon successful completion of all probation requirements ordered by the Court, the Defendant will pay a one-time dismissal fee of \$50.00 after 60 days and a final conviction will not be reported on the Defendant's record. Generally, to qualify for Deferred Disposition a Defendant cannot have a Commercial Driver's License (CDL), committed their speeding violation of 25 plus over the posted limit and have not committed their violation within a construction work zone. I hereby acknowledge that I have read the Deferred Disposition Admonishment and am hereby requesting the Court to grant me Deferred Disposition in my case(s). Defendants 25 and under must complete a Driver's Safety Course to defer the violation.

_____ I understand that I **CANNOT** take the driving safety course if I possess a Commercial driver's license or committed a serious traffic offense.

_____ I understand that I **CANNOT** take the driving safety course if the citation was issued in a work zone with workers present.

_____ I understand that I **CANNOT** take the driving safety course if I am accused of speeding 25 mph or more over the posted limit.

_____ I ENCLOSED a valid photocopy of my Texas Driver's License or permit or proof of Active duty military service if I possess a non-Texas Driver's License.

_____ I ENCLOSED proof of Financial Responsibility (insurance). (A photocopy is acceptable – **NO ORIGINALS PLEASE!**)

_____ **Instead of paying the traffic fine, I ENCLOSE a money order or cashier's check in the amount of \$144.00 (or 169.00 if in school zone) to pay for the court costs for Driver's Safety Course (make payable to the Bremond Municipal Court).**

_____ I understand that I **MUST** provide the Court with a copy of my 3A Driving Record. (You may go online at www.texas.gov)

_____ I understand that I am responsible for completing a Texas DPS approved Driving Safety Course before the expiration of the 90-day extension and remitting the **SIGNED "COURT COPY"** of the Certificate of Completion to the Court.

_____ I understand that this form **MUST** be **NOTORIZED**. (Check with your local bank or school Administration Office).

_____ If mailed, I understand that this form **MUST** be sent **CERTIFIED MAIL**. (Check with your Local Post Office).

_____ **This form and payment of \$144.00 must be turned into the court by the APPEAR DATE located on the citation.**
