The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Thursday November 21, 2024, with the following present: Mayor Swick, Pro-Tem Wilganowski; Councilmember's Mikolajewski, Boudreaux, Kujawa, Burnett, City Secretary Zan, Donald Allman and Eric Bagwell.

1. Mayor Swick called the meeting to order at 6:30p.m.
2. Pledge of Allegiance.
3. Public Comments on Non- Agenda Items. Eric Bagwell addressed the council on the upcoming Republican Party Event January 6, 2025.
4. Public Comments on Agenda Items. No one spoke.
