BE PROSECUTED HEREIN OR UNDER OTHER APPLICABLE LAW; REPEALER; SEVERABILITY; EFFECTIVE DATE; AND COMPLIANCE WITH CHAPTER 551 TEX. GOV. CODE AND CHAPTER 52 TEX. L. GOV. CODE.

25. AN ORDINANCE OF THE CITY OF BREMOND, TEXAS PROVIDING DEFINITIONS GENERALLY APPLICABLE TO CITY ORDINANCES AND MAKING A VIOLATION OF A CITY ORDINANCE, CITY RULE, OR POLICE REGULATION OF THE CITY OF BREMOND A CRIMINAL VIOLATION (MISDEMEANOR) AND PROVIDING:

- A PUNISHMENT BY A FINE NOT TO EXCEED \$500.00 PER DAY OF VIOLATION.
- A PUNISHMENT BY A FINE NOT TO EXCEED \$2000.00 PER DAY FOR SUCH VIOLATION REGARDING FIRE SAFETY, ZONING, OR PUBLIC HEALTH AND SANITATION (OTHER THAN THE DUMPING OF REFUSE) IF THE VIOLATION IS COMMITTED INTENTIONALLY, KNOWINGLY, RECKLESSLY, OR WITH CRIMINAL NEGLIGENCE; AND,
- A PUNISHMENT BY A FINE NOT TO EXCEED \$4000.00 PER DAY FOR SUCH VIOLATION REGARDING THE DUMPING OF REFUSE IF THE VIOLATION IS COMMITTED INTENTIONALLY, KNOWINGLY, RECKLESSLY, OR WITH CRIMINAL NEGLIGENCE.

AN ORDINANCE OF THE CITY OF BREMOND, TEXAS DEFINING AND DECLARING A PUBLIC NUISANCE; MAKING THE CAUSING, PERMITTING, OR ALLOWING OF A PUBLIC NUISANCE A CRIMINAL OFFENSE; ESTABLISHING A PENALTY BY A FINE OF UP TO \$200.00 PER DAY PER OFFENSE; PROVIDING THAT THIS ORDINANCE DOES NOT AFFECT A RIGHT, REMEDY OR PENALTY UNDER OTHER LAW; PROVIDING THAT OFFENDING CONDUCT CAN BE PROSECUTED HEREIN OR UNDER OTHER APPLICABLE LAW; REPEALER; SEVERABILITY; EFFECTIVE DATE; AND COMPLIANCE WITH CHAPTER 551 TEX. GOV. CODE AND CHAPTER 52 TEX. L. GOV. CODE.

### **Citizen Participation**

**This is an opportunity for the public to address the City Council Comments. Public comments are limited to three (3) minutes per speaker, unless the speaker requires the assistance of an interpreter, in which case the speaker is limited to six (6) minutes, in accordance with applicable law. Speakers are not allowed to donate their time. To address the City Council, each speaker who is present at the site must complete a Speaker Form and provide it to the City Secretary prior to the start of the meeting. Each speaker shall approach the designated speaker location and state his/her name and city of residence**

before speaking. Speakers shall address the City Council with civility that is conducive to appropriate public discussion. Speakers can address only the City Council and not individual city officials or employees. The public cannot speak from the audience but only from the designated speaker location. This is an opportunity for citizens to comment upon city business and city business only.
