

Regular Meeting of the Bremond City Council

April 21, 2022

The regular meeting of the Bremond City Council was held in the City Hall at 6:30p.m., Thursday April 21, 2022, with the following present: Mayor Swick; Councilmember's, Boudreaux, Mikolajewski, Kujawa, City Secretary Zan, Chief Pope, Alan Stilley, Koty Kuzinarek and Kie Muzyka.

1. Mayor Swick called the meeting to order at 6:32p.m.
2. Pledge of Allegiance.
3. Public comments on agenda items- No one spoke during the allotted time.
4. Public comments on non-agenda items- No one spoke during the allotted time.
5. Councilmember Mikolajewski made a motion to approve the minutes of the March 17, 2022, Regular City Council Meeting. Seconded by Councilmember Boudreaux. Vote unan.
6. Payment of current City bills- Councilmember Kujawa made a motion to approve payment of the current city bills totaling \$42,911.49 dollars. Seconded by Councilmember Boudreaux. Vote unan.
7. Tax A/C Report for February 2022 and March 2022. No report for March 2022.
8. Mayor's Monthly Report- Mayor Swick gave the Council an update on some Economic Development training May 2022 in Franklin that might open the city to some money for street. Janet's is closing June 18, 2022. Dollar General will start construction in July 2022. DRP Grant for sidewalks paperwork is complete. Mayor Swick is going to speak with Robert Yezak and see if they would help with the expense the City incurred during a house for where a main waterline broke in three places. No action taken.
9. Water Dept.-Public Works Director Kloss provided a written report.

11. Municipal Court Report- Court Clerk Solley provided a written report.
12. Police Dept. – Chief Pope presented a written report.
13. Bremond Chamber of Commerce- Mayor Swick gave the Council update of Polish Day June 24th 25th 2022. Chamber of Commerce was awarded \$27,250.00 dollars from the hotel motel tax. No action taken.
14. Fire Dept. Report- Alan Stilley and Koty Kuzinarek updated the Council on their upcoming annual crawfish boil April 30, 2022. Koty stated there are some fire hydrants they can't get open Mayor Swick stated Public Works will check on them and there are some tree limbs that need to be addressed that are hanging over the streets.
15. Bremond Housing Authority- No report.
16. Councilmember Mikolajewski made a motion to select Goodwin-Lasiter-Strong engineering as the service provider to complete project implementation for American Rescue Plan Act (ARP Act) funding administered by the U.S. Department of the Treasury, other Federal or State Agency. Seconded by Councilmember Kujawa. Vote unan.
17. Councilmember Mikolajewski made a motion to approve placing the Splash Pad on City Property at 217 S. Dallas St., Bremond, Texas and writing a check for \$10,300.00 dollars from the approved Type-B splash pad fund to Goodwin-Lasiter-Strong for engineering fees. Seconded by Councilmember Boudreaux. Vote unan.
18. City Street Renovations- No action taken.
19. Councilmember Boudreaux made a motion to approve \$10.00 hourly for City of Bremond Election early voting and election day workers. Seconded by Councilmember Kujawa. Vote unan.
20. City of Bremond Ordinance Updates- No action.

21. Councilmember Boudreaux made a motion to approve resolution closing State Hwy 46/ Main Street Friday June 24th and Saturday June 25th 2022 for Polish Day. Seconded by Councilmember Mikolajewski. Vote unan.
22. Councilmember Kujawa made a motion to approve the generator gas line bid from N & N Services for \$1500.00 dollars. Seconded by Councilmember Mikolajewski. Vote unan.
23. Modification Plat Dollar General Commerce and Collin Street. No action taken.
