

Regular Meeting of the Bremond City Council
City of Bremond
April 22, 2021

The regular meeting of the Bremond City Council was held in the City Hall at 6:30p.m., Thursday April 22, 2021, with the following present: Mayor Swick; Councilmember's, Boudreaux, Mikolajewski, Wilganowski, Kujawa, City Secretary Zan, Chief Pope, Erica Gray and Kie Muzyka.

1. Mayor Swick called the meeting to order at 6:30p.m.
2. Pledge of Allegiance.
3. Visitors- Mr. Muzyka addressed the Council regarding trashcans on Denton Street, City of Bremond Facebook Page, water in the ditches and he has purchased property on the corner of Anderson and Hunt Street.
4. Councilmember Wilganowski made a motion to approve the minutes of the March 18, 2021 Regular City Council Meeting. Seconded by Councilmember Mikolajewski. Vote unan.
5. Payment of current City bills- After Council discussion on the City's bill for \$14,704.06 received from Robertson County Election Administrator for the City of Bremond's November Election Councilmember Boudreaux made a motion to deny the payment to Robertson County Election Administrator for the \$14,704.06 and approve payment of the remaining city bills totaling \$38,799.58 dollars. Seconded by Councilmember Kujawa. Vote unan.
6. Tax A/C Report- Councilmember Kujawa made a motion to approve the Tax A/C report for March 2021. Seconded by Councilmember Wilganowski. Vote unan.
7. Councilmember Wilganowski made a motion to approve Frontier Waste Solutions 3% residential rate increase effective July 1, 2021. Seconded by Councilmember Boudreaux. Vote unan.
8. Mayor's Monthly Report- Mayor Swick gave the Council and update on a quote for \$48,000. Dollars from 3-B Dozer to demolish 205 S. Main and he has an appointment on May 5, 2021 at City Hall regarding the foundation cracks. No action taken.
9. Water Dept.-Public Works Director Kloss provided a written report.
10. Utility Clerk Report- Utility Clerk Solley provided a written report.
11. Municipal Court Report- Court Clerk Solley provided a written report.
12. Police Dept. – Chief Pope presented a written report.
13. Bremond Chamber of Commerce- Mayor Swick gave the Council update of Polish Day 2022, Chamber Easter event profit \$1500.00 dollars and next Chamber meeting May 12, 2021. No action taken.
14. Bremond Housing Authority- Assistant Executive Director Gray updated the Council and discussed the dogs and noise from neighbors next door. No action taken.
15. Fire Dept. – Councilmember Kujawa gave update on the Annual Crawfish fundraiser date will be 11:00 am April 24, 2021. No action taken.
16. COVID-19- FEMA cutoff date April 26, 2021. No action taken.
17. City Street Renovations- Mayor Swick updated the Council that Street renovations should resume September 2021. No action taken.
18. Councilmember Boudreaux made a motion to approve Palasota Contracting LLC bid of \$8000.00 dollars to demolish house at 217 South Dallas St. Seconded by Councilmember Mikolajewski. Vote unan.
19. Councilmember Boudreaux made a motion to approve Mayor Swick have a meeting with the Robertson County Election board committee regarding the invoice for the City of Bremond's November 3, 2020 election. Seconded by Councilmember Mikolajewski. Vote unan.

20. Councilmember Boudreaux made a motion to approve letter from Type-B Corporation to Rowdy's Bar for repayment of five thousand (\$5000.00) dollars in accordance with Section 6 Melissa Allen defaulted this agreement (v) Permanent cessation of business by the Funding Recipient within three years of funding. and (vi) Insolvency of the Funding Recipient within three years of funding; if for any reason the business closes its doors within three years of funding the money must be paid back. The Type-B Committee voted unanimously on April 5, 2021 Melissa Allen pay back the five thousand dollars (\$5000.00) at the rate of one-hundred fifty dollars (\$150.00) per month for 33 months with final payment of fifty dollars (\$50.00) the 34th month. Seconded by Councilmember Wilganowski. Vote unan.
