

Regular Meeting of the Bremond City Council

The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Thursday March 18, 2021 with the following present: Mayor Swick; Councilmember's Mikolajewski, Wilganowski, Kujawa, Burnett, Boudreaux, City Secretary Zan, City Attorney Lessman, Officer Cook, Kie Muzyka, Alan Stilley and Koty Kuzinarek.

1. Mayor Swick called the meeting to order at 6:30p.m.

22. Councilmember Boudreaux made a motion to approve letter from Type-B Corporation to Cool Dayz Snowcones for repayment of five thousand (\$5000.00) dollars in accordance with Section 6

Jackie Hickman Wilson defaulted this agreement (v) Permanent cessation of business by the Funding Recipient within three years of funding. and (vi) Insolvency of the Funding Recipient within three years of funding; if for any reason the business closes its doors within three years of funding the money must be paid back. The Type-B Committee voted unanimously on January 25, 2021 Jackie Hickman Wilson pay back the five thousand dollars (\$5000.00) at the rate of one-hundred fifty dollars (\$150.00) per month for 33 months with final payment of fifty dollars (\$50.00) the 34<sup>th</sup> month.
