1. Mayor Swick called the meeting to order at 6:31p.m.
2. Pledge of Allegiance.

6. Elect Mayor Pro-Tem- Councilmember Boudreaux made a motion to Elect Councilmember Wilganowski as Mayor Pro-Tem. Seconded by Councilmember Mikolajewski. Vote unan.
7. Visitors- No one spoke during the time allotted for visitors to speak.
8. Councilmember Boudreaux made a motion to approve the minutes of the October 15, 2020 Regular City Council Meeting. Seconded by Councilmember Kujawa. Vote unan.
9. Payment of Current Bills- Councilmember Kujawa made a motion to approve payment of the current City Bills totaling \$38,470.08 dollars. Seconded by Councilmember Boudreaux. Vote unan.

18. Police Dept. Report- Chief Pope presented a written report and introduced Mark Morris to the Council a reserve office for the Bremond Police Dept. No action.
19. Councilmember Boudreaux made a motion to approve Robertson County Tax A/C Tax Roll – Jurisdiction Summary. Seconded by Councilmember Mikolajewski. VOTE 3-FOR-2-ABSENT.
20. Order of Resolution the City of Bremond votes for Robertson Central Appraisal District Board of Directors 2021-2022 Official Ballot. No action.
21. Councilmember Mikolajewski made a motion to approve the closing of State Hwy 46 on December 14, 2019 four hours or less for the Bremond Chamber of Commerce Christmas Committee Parade. In which case that qualifies as a “Routine Traffic Control” event and only requires notification to us of the closure (what, where, why, hours, PD handling TCP?) in a letter or email. If for more than 4 hours, then it needs to be the full agreement with insurance. Seconded by Councilmember Kujawa. Vote unan.
22. City Street Renovations- Discussion only no action.
23. COVID-19- Discussion only no action.
24. Falls Community Clinic 201 South Main Street. No action.
Councilmember Mikolajewski made a motion to approve TML Health Benefits Pool/Blue Cross Shield of Texas Option 1 – Transition to Blue Cross Blue Shield on your anniversary date of 10/1 and switch deductible & out of pocket maximum accumulations to line up with plan year. The deductible and out of pocket maximum accumulations will be pro-rated from January to September. Seconded by Councilmember Kujawa. Vote unan.
1. Councilmember Boudreaux made a motion to approve AN ORDINANCE RELATING TO SPEED ZONES WHICH SPECIFICALLY DESIGNATES ADDITIONAL AREAS IN THE CITY OF BREMOND IN WHICH RATES OF SPEED OF THIRTY (30) MILES PER HOUR OR MORE ARE AUTHORIZED; RESCINDING ALL PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND DECLARING THAT ATTENDANT FACTS NECESSITATE IMMEDIATE ACTION. Seconded by Councilmember Mikolajewski. Vote unan.
