The regular meeting of the Bremond City Council was held in City Hall at 6:30pm, Thursday October 21, 2021, with the following present: Mayor Swick; Councilmember's Mikolajewski, Burnett, Boudreaux, Kujawa, Wilganowski, City Secretary Zan.

1. Mayor Swick called the meeting to order at 6:30p.m.
2. Pledge of Allegiance.
