## **Citizen Participation**

Speakers are not allowed to donate their time. To address the City Council, each speaker who is present at the site must complete a Speaker Form and provide it to the City Secretary prior to the start of the meeting. Each speaker shall approach the designated speaker location and state his/her name and city of residence before speaking. Speakers shall address the City Council with civility that is conducive to appropriate public discussion. Speakers can address only the City Council and not individual city officials or employees. The public cannot speak from the audience but only from the designated speaker location. This is an opportunity for citizens to comment upon city business and city business only.
