

Regular Meeting of the Bremond City Council

The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Thursday May 15, 2025, with the following present: Mayor Wilganowski; Councilmember's Kujawa, Cook, Mikolajewski, Boudreaux, City Secretary Zan, Chief Cook, Public Works Director Kloss, K L Groholski and Kie Muzyka.
