

Regular Meeting of the Bremond City Council
City of Bremond
August 21, 2025

The regular meeting of the Bremond City Council was held in City Hall at 6:30pm Thursday August 21, 2025, with the following present: Mayor Wilganowski; Mayor Pro-Tem Burnett, Councilmember's Cook, Kujawa, Mikolajewski, City Secretary Zan, Police Chief Cook, Public Works Director Kloss, Eric Jones, Susan Jones and Kie Muzyka.

1. Mayor Wilganowski called the meeting to order at 6:33p.m.
2. Pledge of Allegiance.
3. Public Comments on Non-Agenda Items- No one.
4. Public Comments on Agenda Items- No one.
5. Councilmember Cook made a motion to approve the July 17, 2025, Regular Council Meeting. Second, by Councilmember Kujawa. Vote unan.
6. Payment of Current Bills- Councilmember Burnett made a motion to approve payment of the city bills totaling \$67,753.95 dollars. Seconded by Councilmember Cook. Vote unan.
7. Tax A/C Report- July 2025 no report.
8. Councilmember Mikolajewski made a motion to approve Mr. Muzyka's request to move the Farmers Market back to the City of Bremond Lumber Yard Park property from the City of Bremond Park on Commerce Street. Second by Councilmember Kujawa. Vote unan.
9. Eric and Susan Jones addressed the Council on the power surges/outages with Entergy. Mr. Jones told the Council Entergy has not done any line maintenance in this area since 2018 and that 2025 is Entergy's scheduled maintenance year. Mr. Jones said Entergy came to his house on August 11, 2025, and installed a device so they can monitor the issues he is having with the power. Councilmember Burnett said he has frequent issues as well and has probably 40 more hours on his generator than his family 1 block down on theirs. Council told Mr. Jones to keep them updated and if there is anything they can assist him with to let them know. No action taken discussion only

13. Police Dept -Police Chief Cook presented a written report to the Council. Chief Cook asked the Council for permission to allow him to sign a contract with AXON for evidence storage for the body cameras. Councilmember Mikolajewski made a motion to approve Chief Cooks request. Second by Councilmember Kujawa. Vote unan.

16. Councilmember Cook made a motion to wave the non-refundable service charge of \$175.00 for the Bremond Chamber of Commerce building for water /sewer service and charge month for water/sewer service. Second by Councilmember Mikolajewski. Vote unan.
17. Councilmember Burnett made a motion to approve the City of Bremond providing Ice Cream for the BVFD annual National Night Out. Second by Councilmember Kujawa. Vote unan.
18. City Street Renovations- Councilmember Mikolajewski made a motion to approve ordering two loads of oil when Commissioner Taylor is ready to work on the street renovation. Second by Councilmember Kujawa. Vote unan.
19. Councilmember Mikolajewski made a motion to approve Type-A funding proposal from the Bremond Chamber of Commerce for \$3000.00 dollars for Polish Day 2025 advertising., Second by Councilmember Kujawa. Vote unan.
20. Councilmember Cook made a motion to approve Type-B funding proposals from Bremond Chamber of Commerce Christmas Committee \$2187.28, Main Street Market \$5000.00, Bremond Laundry & Car Wash \$5000.00 and Alligator Creek Nursery \$5000.00 dollars. Second by Councilmember Burnett. Vote unan.

23. Councilmember Burnett made a motion to propose a Tax Rate of \$0.39000/\$100 for 2025. Seconded by Councilmember Mikolajewski. Vote unan.
