

Grandview Plaza City Council

Met in Regular Session July 17, 2018 at 6:30 PM

Meeting was called to order at 6:30 pm, by Mayor Rick Geike. Present were council members Gary Sacher, Honey Grant, Marvin Edison, Allan Rothlisberg. and Robert Rodney. Also present was, Janet Young, Chief Shawn Peirano, Jerome Thomas, Officer Wyatt Charlson, Gerry Bielefeld, Carol Hicks, and Wayne Sawicki.

Mayor Geike led the Pledge of Allegiance.

Honey Grant led the Invocation.

Gary Sacher made a motion to approve the June 19, 2018 minutes. Allan Rothlisberg seconded the motion. Motion carried, vote unanimous.

Dan Hoffman provided the council with a preliminary budget. Dan suggested that the council members look over the proposed budget/expenditures. A special budget meeting was set up for 7/31/2018 at 6:30 pm.

Jerome Thomas advised the council of the following:

- 1) Provided council a list of budget items requested for 2019
- 2) Asked council for a motion to approve the air conditioning unit at the community center. Marvin Edison made the motion to approve the purchase. Gary Sacher seconded the motion. Motion carried, vote unanimous.
- 3) Advised that streets had been started. Requested to have the corner of State and West Grandview Drive asphalted for a cost of \$800.00 to \$1000.00 Robert Rodney made a motion to approve the repair. Honey Grant seconded the motion. Motion carried, vote unanimous.
- 4) Advised that there has been a problem with the water pressure that the city receives from Junction City. Advised that there has been several low meter alarms. Requested permission to purchase a Turbine Meter for \$2300.00. This meter would replace the current meter to the city and would elevate the water pressure problem. Marvin Edison made a motion to purchase the meter. Allan Rothlisberg seconded the motion. Motion carried, vote unanimous.
- 5) Advised the council that Greg's work truck had to be repaired. Buds Auto Service.

Chief Peirano advised the council of the following:

- 1) Requested permission to hire up to 6 part time officers at \$16.00 hour. Marvin Edison made a motion to approve the hiring. Allan Rothlisberg seconded the motion. Motion carried, vote unanimous.

Janet Young advised the council of the following:

- 1) Present council with policy on compensatory time. Allan Rothlisberg made a motion to approve the policy. Marvin Edison seconded the motion. Motion carried, vote unanimous.

Gary Sacher moved to approve the June expenditures, seconded by Allan Rothlisberg. Motion carried, vote unanimous.

Honey Grant moved to approve the June financial statement, seconded by Gary Sacher. Motion carried, vote unanimous.
