

Grandview Plaza City Council

Met in Regular Session December 20, 2022 at 5:30 PM

Meeting was called to order at 5:30 pm, by Mayor Rick Geike. Present were council members, Ronald Woods, Honey Grant, Art Potter, Tanya Thurn and Harlan Loftus. Also present were, Janet Young, Chief Peirano, Roger Unruh, Luke Erichsen, Officer Kyle Porter, Captain Joshua Williams, Officer Tyler Hynes, Officer Sherry Vallon and Samantha Boyd.

Mayor Geike led the Pledge of Allegiance

Honey Grant led the Invocation.

Art Potter made a motion to approve the November 15, 2022 minutes. Harlan Loftus seconded the motion. Motion carried, vote unanimous.

Luke Erichsen advised the council of the following:

- 1) Advised the council that intersections are completed
- 2) Advised the council that he believed they were ready for the upcoming storm

Jeremy Bramwell was not present, he called out sick

Eric Duntz from 128 E Anchor advised the council that he had about 1 more big roll away trash container worth of items to have removed from property. Trailer has been demolished and he is just working on clean up.

Mark Pearson was present to represent Wayne Pearson (owner of property at 304 State). Mr. Pearson advised that he would demolish the trailer, and clean up the property instead of having the city set it out for bid at no cost to the city. Honey Grant made a motion to allow Mark Pearson to demolish the trailer and clean up the property at 304 State St. at no cost to the City of Grandview Plaza. Ronald Woods seconded the motion. - 3) Advised the council that the blight at 104 E Anchor had not been cleaned up. Advised council that she forgot to have the police department check the property on Dec. 01, 2022 so the residents will be getting a citation to come to court on January 12, 2023.
