## Grandview Plaza City Council

## Met in Regular Session March 19, 2019 at 6:30 PM

Meeting was called to order at 6:30 pm, by Mayor Rick Geike. Present were council members Gary Sacher, Marvin Edison, Allan Rothlisberg, Honey Grant and Robert Rodney. Also present was, Jerome Thomas Janet Young, Chief Shawn Peirano, Herta Cherico, John Day, Silas Keim and family, and Officer Kit Landry

Mayor Geike led the Pledge of Allegiance

Honey Grant led the Invocation.

Honey Grant made a motion to approve the February 26, 2019 minutes. Allan Rothlisberg seconded the motion. Motion carried, vote unanimous.

John Day addressed the council about the animal ordinance #12-0001. John Day requested that the council remove the breed specific (pit bull dogs) from the ordinance and to just have a dangerous animal section. Marvin Edison made a motion to leave ordinance #12-0001 as it stands. Robert Rodney seconded the motion. Motion carried, vote unanimous.

Jerome Thomas advised of the following:

- 1) The water towers had been frozen, however, they are thawing
- 2) That during the recent power outage, it was brought to our attention that the fire truck barn and the police garage were inaccessible. The generators were also inaccessible. Jerome provided two quotes for the fire barn doors and police doors were hooked into the generator at the community center. \$2650.00 for all the doors, city would provided the wire and would do the necessary digging. \$1705.00 for just the fire doors. Robert Rodney made a motion to have all doors run to the generator for \$2650.00. Honey Grant seconded the motion. Motion carried, vote unanimous.

Chief Peirano advised the council of the following:

- 1) Advised council that the police department had responded to 431 calls for service.
- 2) Advised the council that Officer Dipolito turned in his resignation, effective 4/26/2019.
- 3) Requested permission to start the hiring process to fill that slot. Marvin Edison made a motion to have Chief Peirano start the hiring process. Gary Sacher seconded the motion. Motion carried, vote unanimous.
- 4) Advised the council that the Kansas Law Enforcement Center (KLETC) was able to get Officer Batstone into the April 8, 2019 class.

Janet Young advised the council of the following:

- Presented Resolution 19-01, a resolution to have the 1% sales tax be placed on the November 2019 ballot. Marvin Edison made a motion to pass resolution 19-01. Gary Sacher seconded the motion. Motion carried, vote unanimous.
- Provided the council with a copy of the request for an amended KDHE loan for the sewer lagoons. Allan Rothlisberg made a motion to approve the loan paperwork as written. Marvin Edison seconded the motion. Motion carried, vote unanimous.

Gary Sacher moved to approve the February expenditures, seconded by Robert Rodney. Motion carried, vote unanimous.

Robert Rodney moved to approve the January financial statement, seconded by Gary Sacher. Motion carried, vote unanimous.

Allan Rothlisberg made a motion to adjourn. Robert Rodney seconded the motion. Motion carried, vote unanimous.
