THIS IS A ONE-OFF FEE FOR THE YEAR PAYABLE UPON ENROLMENT WHICH COVERS INSURANCE AND REGISTRATION AND IS NON-REFUNDABLE.

## CLASS ETIQUETTE

## **UNIFORM**

- ALL STUDENTS ARE TO WEAR THE CORRECT UNIFORM TO CLASS. STUDENTS ARE TO BE NEAT AND PRESENTABLE WITH THEIR HAIR TIED BACK. IN A BUN FOR BALLET, A PONYTAIL IS OKAY FOR ALL OTHER LESSONS.
- DANCE SHOES ARE NOT TO BE WORN OUTSIDE OF THE STUDIO
- IMDS UNIFORM IS COMPULSORY WHEN REPRESENTING THE STUDIO IN PUBLIC. THIS INCLUDES STUDIO JUMPER AND SINGLET.

## **PAYMENT OF FEES**

- ALL TERM FEES ARE DUE WITHIN 14 DAYS FROM THE DATE THE INVOICE IS ISSUED UNLESS CLASSES ARE PAID WEEKLY/FORTNIGHTLY. ANY OVERDUE AMOUNTS WILL OCCUR A LATE FEE OF \$10.00 PER WEEK THAT THE AMOUNT IS OVERDUE.
- IF TERM FEES ARE STILL OUTSTANDING AT THE BEGINNING OF THE FOLLOWING TERM, THE STUDENT'S ENROLMENT WILL BE TEMPORARILY CANCELLED UNTIL FEES ARE BROUGHT UP TO DATE.


